A BILL FOR AN ACT

101 **CONCERNING THE CONSOLIDATION OF WILDLIFE ENTITIES WITH PARKS**
102 **AND OUTDOOR RECREATION ENTITIES UNDER THE DEPARTMENT**
103 **OF NATURAL RESOURCES.**

Bill Summary

Effective July 1, 2011, the bill combines the following entities, all of which are located within the department of natural resources (department), as follows:

outdoor recreation are merged to form a new parks and wildlife board (new board); and

- ! The division of wildlife and the division of parks and outdoor recreation are consolidated into a new division of parks and wildlife (new division).

Section 2 of the bill creates the new board and the new division. The new board consists of 16 members (the 11 members of the existing wildlife commission and the 5 members of the existing board of parks and outdoor recreation). The new division is under the direction of a single director, who will be chosen by the members of the wildlife commission and the board of parks and outdoor recreation, with the consent of the executive director of the department, and whose term begins July 1, 2011.

The new board and the new division each assume the duties, powers, and responsibilities previously exercised by their predecessor entities, which functions and duties otherwise remain intact. Similarly, all funds and expenditures of moneys from funds continue unaltered, and the new board is charged specifically with developing accounting procedures to ensure that moneys under its control are expended consistent with the purposes for which the moneys were received.

Section 3 amends the "Administrative Organization Act of 1968" to reflect the existence and character of the new board and new division, and **section 4** alters the statute listing subdivisions of the department.

Sections 5 through 11 amend current laws pertaining to wildlife, parks, and outdoor recreation to reflect the existence of the new board and new division, including, notably:

- ! Repealing and relocating duplicative or obsolete language regarding the composition, character, and terms of the new board; and
- ! Amending the defined terms "wildlife commission" and "board of parks and outdoor recreation" to mean the new board, and redefining "division of wildlife" and "division of parks and outdoor recreation" to mean the new division.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1. Legislative declaration.** (1) The general assembly
3 hereby finds, determines, and declares that:


4 (a) The people of Colorado value and seek to preserve the state's
5 unique park, wildlife, and outdoor recreation heritage;

6 (b) Maintenance of a healthy outdoor recreation program is vital
7 to local, regional, and state economies;

1 (c) It is important to leverage existing fiscal, personnel, and
2 capital resources to achieve the greatest accountability, efficiency, and
3 customer-focused service delivery possible;

4 (d) Combining similar or overlapping programs and functions has
5 the potential to reduce costs, streamline processes, and provide a net
6 benefit to state budgets;

7 (e) Coloradans and visitors to the state will benefit from the
8 preservation of important programs, such as the aquatic nuisance species
9 program, the recreational trails program, and the natural areas program,
10 that would otherwise need to be scaled back or eliminated under current
11 budget proposals;

12 
13 (f) Policies, procedures, and accounting methods to ensure
14 transparency, to prevent the unauthorized commingling or impermissible
15 use of moneys in distinct funds, and to ensure that moneys are expended
16 consistent with the purposes for which they are received, collected, or
17 appropriated are fundamental to any successful effort to realize
18 efficiencies;

19 (g) Preserving the missions of the division of wildlife and division
20 of parks and outdoor recreation is a priority, as is transparency of the
21 process for combining functions, streamlining processes, and reducing
22 costs; and

23 (h) The board of parks and outdoor recreation and the wildlife
24 commission have created strategic plans that identify goals and objectives
25 for the division of parks and outdoor recreation and the division of
26 wildlife for the next five to ten years, and combining divisions so that
27 resources are shared and allocated toward the achievement of shared and

- 1 mutually beneficial goals will further these objectives, including:
- 2 (I) Protecting, restoring, and enhancing habitats;
 - 3 (II) Providing and protecting opportunities for hunting, fishing,
4 and wildlife-viewing opportunities;
 - 5 (III) Enforcing regulations that protect fish and wildlife;
 - 6 (IV) Increasing public knowledge of agency missions;
 - 7 (V) Increasing public awareness of, and participation in, a variety
8 of outdoor activities;
 - 9 (VI) Attracting and retaining a diverse workforce and promoting
10 excellence within that workforce;
 - 11 (VII) Creating and strengthening outreach and partnerships; and
 - 12 (VIII) Maximizing funding.

13 **SECTION 2.** Title 33, Colorado Revised Statutes, is amended BY
14 THE ADDITION OF A NEW ARTICLE to read:

15 **ARTICLE 9**

16 **Administration of Parks and Wildlife**

17 **33-9-101. Board - creation - composition - terms - vacancies -**
18 **removal - meetings.** (1) THERE IS HEREBY CREATED THE PARKS AND
19 WILDLIFE BOARD, ALSO REFERRED TO IN THIS ARTICLE AS THE "BOARD".

20 (2) (a) THE BOARD CONSISTS OF SIXTEEN MEMBERS, AS FOLLOWS:

21 (I) TWO MEMBERS, THE EXECUTIVE DIRECTOR AND THE
22 COMMISSIONER OF THE DEPARTMENT OF AGRICULTURE, WHO ARE EX
23 OFFICIO NONVOTING MEMBERS; AND

24 (II) THE FOLLOWING FOURTEEN VOTING MEMBERS, WHO ARE
25 APPOINTED BY THE GOVERNOR WITH THE CONSENT OF THE SENATE:

26 (A) NINE MEMBERS APPOINTED PURSUANT TO PARAGRAPH (c) OF
27 THIS SUBSECTION (2), OF WHOM NOT MORE THAN FIVE MAY BE OF THE

1 SAME POLITICAL PARTY; AND

2 (B) FIVE MEMBERS APPOINTED PURSUANT TO PARAGRAPH (d) OF
3 THIS SUBSECTION (2), OF WHOM NOT MORE THAN THREE MAY BE OF THE
4 SAME POLITICAL PARTY.

5 (b) NOTWITHSTANDING SUBPARAGRAPH (II) OF PARAGRAPH (a) OF
6 THIS SUBSECTION (2), THE FOURTEEN VOTING MEMBERS OF THE BOARD
7 ORIGINALLY CONSIST OF THE NINE VOTING MEMBERS OF THE WILDLIFE
8 COMMISSION, AS THE COMMISSION EXISTED ON JUNE 30, 2011, AND THE
9 FIVE MEMBERS OF THE BOARD OF PARKS AND OUTDOOR RECREATION, AS
10 THE BOARD OF PARKS AND OUTDOOR RECREATION EXISTED ON JUNE 30,
11 2011. SUBJECT TO SUBSECTION (5) OF THIS SECTION, THESE MEMBERS
12 MAY SERVE OUT THE TERMS TO WHICH THEY WERE ORIGINALLY
13 APPOINTED. IF A VACANCY OCCURS ON THE BOARD FOR ONE OF THESE
14 ORIGINAL MEMBERS, THE GOVERNOR SHALL APPOINT A PERSON TO FILL
15 THE REMAINDER OF THAT MEMBER'S UNEXPIRED TERM.

16 (c) **Board members with wildlife knowledge.** THE NINE
17 MEMBERS OF THE BOARD APPOINTED UNDER THIS PARAGRAPH (c) MUST
18 HAVE A REASONABLE KNOWLEDGE OF WILDLIFE ISSUES, WILDLIFE
19 HABITAT, OR WILDLIFE MANAGEMENT, AND SHALL BE APPOINTED AS
20 FOLLOWS:

21 (I) **Geographical representation.** AT LEAST ONE MEMBER MUST
22 BE APPOINTED FROM EACH OF THE FOLLOWING FIVE DISTRICTS, AND NO
23 DISTRICT SHALL BE REPRESENTED BY MORE THAN THREE MEMBERS
24 APPOINTED UNDER THIS PARAGRAPH (c) AT ANY ONE TIME:

25 (A) DISTRICT 1 IS COMPRISED OF THE FOLLOWING COUNTIES:
26 MOFFAT, RIO BLANCO, GARFIELD, MESA, ROUNT, EAGLE, PITKIN,
27 JACKSON, GRAND, AND SUMMIT;

1 (B) DISTRICT 2 IS COMPRISED OF THE FOLLOWING COUNTIES:
2 DELTA, MONTROSE, OURAY, SAN MIGUEL, DOLORES, MONTEZUMA, SAN
3 JUAN, LA PLATA, GUNNISON, HINSDALE, ARCHULETA, SAGUACHE,
4 MINERAL, RIO GRANDE, CONEJOS, ALAMOSA, AND COSTILLA;

5 (C) DISTRICT 3 IS COMPRISED OF THE FOLLOWING COUNTIES:
6 LARIMER, WELD, MORGAN, LOGAN, WASHINGTON, SEDGWICK, PHILLIPS,
7 AND YUMA;

8 (D) DISTRICT 4 IS COMPRISED OF THE FOLLOWING COUNTIES: LAKE,
9 CHAFFEE, PARK, FREMONT, CUSTER, TELLER, EL PASO, PUEBLO,
10 HUERFANO, THOSE LANDS IN ELBERT COUNTY NOT DESIGNATED AS LYING
11 WITHIN DISTRICT 5, LINCOLN, CROWLEY, OTERO, LAS ANIMAS, KIT
12 CARSON, CHEYENNE, KIOWA, BENT, PROWERS, AND BACA;

13 (E) DISTRICT 5 IS COMPRISED OF THE FOLLOWING COUNTIES AND
14 CITIES AND COUNTIES: BOULDER, BROOMFIELD, JEFFERSON, DOUGLAS,
15 ARAPAHOE, ADAMS, ELBERT COUNTY, INCLUDING ONLY TOWNSHIPS 6
16 SOUTH THROUGH 10 SOUTH, RANGE 63 WEST, 64 WEST, AND THAT PART
17 OF 65 WEST LYING WITHIN ELBERT COUNTY, 6TH PRINCIPAL MERIDIAN,
18 COLORADO, CLEAR CREEK, GILPIN, AND DENVER;

19 (II) **Areas of particular knowledge.** OF THE MEMBERS
20 APPOINTED UNDER THIS PARAGRAPH (c), ONE MEMBER MUST BE
21 APPOINTED FROM EACH OF THE FOLLOWING CATEGORIES: LIVESTOCK
22 PRODUCERS; AGRICULTURAL OR PRODUCE GROWERS; SPORTS PERSONS OR
23 OUTFITTERS; SPORTS PERSONS; WILDLIFE ORGANIZATIONS; AND BOARDS OF
24 COUNTY COMMISSIONERS. THE OTHER THREE MEMBERS MUST BE
25 APPOINTED FROM THE PUBLIC AT LARGE. AS USED IN THIS SECTION:

26 (A) "SPORTS PERSON" MEANS ANY HUNTER OR ANGLER WHO HAS
27 PURCHASED OR APPLIED FOR A HUNTING OR FISHING LICENSE FOR EACH OF

1 THE PREVIOUS THREE YEARS OR WHO CAN DEMONSTRATE A REASONABLE
2 KNOWLEDGE OF WILDLIFE ISSUES, WILDLIFE HABITAT, WILDLIFE
3 MANAGEMENT, AND THE COMMISSION'S DUTIES, PROCEDURES, POLICIES,
4 AUTHORITY, AND PAST DECISIONS; AND

5 (B) "WILDLIFE ORGANIZATION" MEANS A NONPROFIT
6 ORGANIZATION, ASSOCIATION, OR CORPORATION REGISTERED WITH THE
7 SECRETARY OF STATE'S OFFICE THAT: HAS ARTICLES OF INCORPORATION,
8 BYLAWS, AND THE FIDUCIARY RESPONSIBILITIES OF OFFICERS AND
9 MEMBERS OF THE BOARD OF DIRECTORS THAT ARE DESIGNED FOR OR
10 RELATED TO THE SPECIFIC PURPOSE OF PROTECTING, ADVERTISING, OR
11 ADVANCING THE CONCERNS OF ITS INDIVIDUAL MEMBERSHIP; SUPPORTS
12 AND PROMOTES THE CONSERVATION AND ENHANCEMENT OF COLORADO'S
13 WILDLIFE AND ITS HABITAT; RECOGNIZES AND PROMOTES PRIMARILY
14 NONCONSUMPTIVE WILDLIFE USE; AND HAS EXPERTISE IN WILDLIFE ISSUES,
15 WILDLIFE HABITAT, OR WILDLIFE MANAGEMENT.

16 (d) **Board members from parks and outdoor recreation**
17 **regions.** THE FIVE MEMBERS APPOINTED TO THE BOARD UNDER THIS
18 PARAGRAPH (d) INCLUDE ONE PERSON APPOINTED FROM THE STATE AT
19 LARGE AND ONE PERSON APPOINTED FROM EACH OF THE FOLLOWING
20 REGIONS:

21 (I) THE WEST REGION, WHICH IS COMPRISED OF THE FOLLOWING
22 COUNTIES: ARCHULETA, DELTA, DOLORES, GARFIELD, GUNNISON,
23 HINSDALE, LA PLATA, MESA, MOFFAT, MONTEZUMA, MONTROSE,
24 OURAY, RIO BLANCO, SAN JUAN, AND SAN MIGUEL;

25 (II) THE NORTH REGION, WHICH IS COMPRISED OF THE FOLLOWING
26 COUNTIES: EAGLE, GRAND, JACKSON, LARIMER, LOGAN, MORGAN,
27 PHILLIPS, PITKIN, ROUTT, SEDGWICK, SUMMIT, WASHINGTON, WELD, AND

1 YUMA;

2 (III) THE METRO REGION, WHICH IS COMPRISED OF THE FOLLOWING
3 COUNTIES AND CITIES AND COUNTIES: ADAMS, ARAPAHOE, BOULDER,
4 BROOMFIELD, CLEAR CREEK, DENVER, DOUGLAS, GILPIN, AND
5 JEFFERSON;

6 (IV) THE SOUTH REGION, WHICH IS COMPRISED OF THE FOLLOWING
7 COUNTIES: ALAMOSA, BACA, BENT, CHAFFEE, CHEYENNE, CONEJOS,
8 COSTILLA, CROWLEY, CUSTER, ELBERT, EL PASO, FREMONT, HUERFANO,
9 KIOWA, KIT CARSON, LAKE, LAS ANIMAS, LINCOLN, MINERAL, OTERO,
10 PARK, PROWERS, PUEBLO, RIO GRANDE, SAGUACHE, AND TELLER.

11 (3) (a) TERMS OF OFFICE ARE FOUR YEARS FOR MEMBERS
12 APPOINTED PURSUANT TO PARAGRAPH (a) OF SUBSECTION (2) OF THIS
13 SECTION.

14 (b) NO MEMBER IS PERMITTED TO SERVE MORE THAN TWO
15 CONSECUTIVE FOUR-YEAR TERMS.

16 (4) THE GOVERNOR SHALL FILL VACANCIES ON THE BOARD FOR
17 ANY UNEXPIRED TERM, WITH THE CONSENT OF THE SENATE.

18 (5) THE GOVERNOR IS PERMITTED TO REMOVE MEMBERS OF THE
19 BOARD ONLY FOR CAUSE.

20 (6) (a) (I) EXCEPT AS PROVIDED IN PARAGRAPH (b) OF THIS
21 SUBSECTION (6):

22 (A) A MAJORITY OF THE BOARD CONSTITUTES A QUORUM FOR THE
23 TRANSACTION OF ANY BUSINESS.

24 (B) THE BOARD MAY TAKE ACTION ONLY UPON THE AFFIRMATIVE
25 VOTE OF A MAJORITY OF A QUORUM.

26 (II) AS USED IN THIS PARAGRAPH (a), "MAJORITY" MEANS:

27 (A) MORE THAN ONE-HALF OF THE MEMBERS WHO ARE PRESENT AT

1 A MEETING OF THOSE BOARD MEMBERS EITHER SERVING PURSUANT TO
2 SUB-SUBPARAGRAPH (A) OF SUBPARAGRAPH (II) OF PARAGRAPH (a) OF
3 SUBSECTION (2) OF THIS SECTION OR APPOINTED PURSUANT TO PARAGRAPH
4 (c) OF SUBSECTION (2) OF THIS SECTION; AND

5 (B) MORE THAN ONE-HALF OF THE MEMBERS WHO ARE PRESENT AT
6 A MEETING OF THOSE BOARD MEMBERS EITHER SERVING PURSUANT TO
7 SUB-SUBPARAGRAPH (B) OF SUBPARAGRAPH (II) OF PARAGRAPH (a) OF
8 SUBSECTION (2) OF THIS SECTION OR WHO WERE APPOINTED PURSUANT TO
9 PARAGRAPH (d) OF SUBSECTION (2) OF THIS SECTION.

10 (b) THE BOARD MAY SPECIFY, BY MAJORITY VOTE, TYPES OF
11 MATTERS UPON WHICH ACTION MAY BE TAKEN BY VOTE OF A SIMPLE
12 MAJORITY. ANY SUCH MATTERS MAY THEREAFTER BE ACTED UPON BY A
13 SIMPLE MAJORITY OF A QUORUM OF THE ENTIRE BOARD.

14 (7) FOR PURPOSES OF MAILING AND SERVICE, THE BOARD'S
15 PRINCIPAL OFFICE IS IN THE OFFICE OF THE EXECUTIVE DIRECTOR.

16 (8) FOR EACH DAY ACTUALLY ENGAGED IN THE DUTIES OF THE
17 BOARD, THE BOARD MEMBERS ARE ENTITLED TO RECEIVE A PER DIEM
18 AMOUNT OF FIFTY DOLLARS, TOGETHER WITH ALL ACTUAL AND
19 NECESSARY TRAVEL EXPENSES TO BE PAID AFTER THE EXPENSES ARE
20 INCURRED. MILEAGE RATES ARE AS PROVIDED IN SECTION 24-9-104,
21 C.R.S.

22 (9) THE BOARD SHALL EXERCISE ITS POWERS AND PERFORM ITS
23 DUTIES AND FUNCTIONS UNDER THE DEPARTMENT AND THE EXECUTIVE
24 DIRECTOR OF THE DEPARTMENT AS IF THE SAME WERE TRANSFERRED TO
25 THE DEPARTMENT BY A **TYPE 1** TRANSFER, AS DEFINED IN THE
26 "ADMINISTRATIVE ORGANIZATION ACT OF 1968", ARTICLE 1 OF TITLE 24,
27 C.R.S.

1 (10) (a) ON OR BEFORE JUNE 15, 2011, THE MEMBERS OF THE
2 WILDLIFE COMMISSION AND THE BOARD OF PARKS AND OUTDOOR
3 RECREATION SHALL MEET AS NECESSARY IN ORDER TO:

4 (I) ELECT, FROM AMONG THEIR MEMBERS, A CHAIRPERSON OR
5 CO-CHAIRPERSONS, VICE-CHAIRPERSON, AND SECRETARY OF THE PARKS
6 AND WILDLIFE BOARD, WHICH OFFICERS HOLD THOSE POSITIONS,
7 BEGINNING JULY 1, 2011, FOR ONE YEAR OR UNTIL SUCCESSORS ARE
8 CHOSEN BY MAJORITY VOTE OF THE BOARD;

9 (II) SCHEDULE, AT A MINIMUM, MONTHLY MEETING DATES
10 THROUGH THE 2011 CALENDAR YEAR, COMMENCING IN JULY 2011, AT
11 WHICH THE BOARD WILL TRANSACT REGULAR BUSINESS IN ADDITION TO
12 FORMULATING THE IMPLEMENTATION PLAN DESCRIBED UNDER PARAGRAPH
13 (b) OF THIS SUBSECTION (10); AND

14 (III) DESIGNATE TWO MEMBERS TO SERVE, BEGINNING JULY 1,
15 2011, AS REPRESENTATIVES TO THE STATE BOARD OF THE GREAT
16 OUTDOORS COLORADO TRUST FUND ESTABLISHED UNDER ARTICLE XXVII
17 OF THE STATE CONSTITUTION. ONE REPRESENTATIVE MUST BE A BOARD
18 MEMBER APPOINTED TO THE WILDLIFE COMMISSION UNDER SECTION
19 33-1-103 AND THE OTHER REPRESENTATIVE MUST BE A MEMBER
20 APPOINTED TO THE BOARD OF PARKS AND OUTDOOR RECREATION UNDER
21 SECTION 33-10-104.

22 (b) IN ADDITION TO DISCHARGING ITS REGULAR DUTIES AND
23 FUNCTIONS, THE BOARD, AT THE MEETINGS SCHEDULED PURSUANT TO
24 SUBPARAGRAPH (II) OF PARAGRAPH (a) OF THIS SUBSECTION (10), SHALL
25 SPECIFICALLY DISCUSS AND FORMULATE AN IMPLEMENTATION PLAN TO
26 ADDRESS OUTSTANDING ISSUES AND IDENTIFY INCREASED EFFICIENCIES
27 AND COST SAVINGS THAT MAY BE REALIZED FROM THE 2011 MERGER OF

1 THE FORMER DIVISION OF WILDLIFE AND THE FORMER DIVISION OF PARKS
2 AND OUTDOOR RECREATION INTO THE DIVISION OF PARKS AND WILDLIFE.
3 THE IMPLEMENTATION PLAN MUST CONSOLIDATE THE OPERATIONS AND
4 PROGRAMS OF THE TWO DIVISIONS IN A MANNER THAT, TO THE GREATEST
5 EXTENT POSSIBLE, ALLOCATES COSTS OVER A REASONABLE PERIOD OF
6 TIME AND WITHIN EXISTING BUDGET LEVELS AND USES THE BOARD'S
7 PARTICULARLY IDENTIFIED COST SAVINGS TO FINANCE THE
8 IMPLEMENTATION PLAN AND TRANSITION. THE IMPLEMENTATION PLAN
9 MUST TAKE INTO ACCOUNT THE REAFFIRMATION OF ASSENT TO THE
10 PITTMAN-ROBERTSON AND DINGELL-JOHNSON ACTS UNDER SECTION
11 33-9-107. THE IMPLEMENTATION PLAN MUST ALSO INCLUDE THE BOARD'S
12 RECOMMENDATIONS FOR RESTRUCTURING THE BOARD, INCLUDING
13 PROPOSALS FOR ITS NAME, SIZE, TERMS, GEOGRAPHICAL AND ISSUE
14 REPRESENTATION, AND MEMBERSHIP QUALIFICATIONS. IN DISCUSSING AND
15 MAKING RECOMMENDATIONS REGARDING RESTRUCTURING THE BOARD,
16 THE BOARD SHALL SPECIFICALLY CONSIDER THE CREATION OF AN
17 ELEVEN-MEMBER BOARD. ALL MEETINGS AT WHICH THE BOARD DISCUSSES
18 THE IMPLEMENTATION PLAN ARE OPEN TO THE PUBLIC, AND THE BOARD
19 SHALL SOLICIT PUBLIC INPUT REGARDING THE IMPLEMENTATION PLAN AND
20 ANY STRATEGIC PLANS AT THOSE MEETINGS. THE BOARD SHALL PROVIDE
21 THE IMPLEMENTATION PLAN TO THE EXECUTIVE DIRECTOR AS ITS FORMAL
22 RECOMMENDATIONS.

4 **33-9-102. Powers and duties of the board - rules.** (1) THE
5 BOARD IS VESTED WITH ALL THE POWERS, RESPONSIBILITIES, OBLIGATIONS,
6 FUNCTIONS, AND DUTIES THAT PREVIOUSLY WERE UNDER THE

23 (4) (a) EXCEPT AS PROVIDED IN PARAGRAPH (b) OF THIS

25 PARK FEE OR CHARGE UNDER ARTICLES 10 TO 32 OF THIS TITLE, THE BOARD
26 SHALL CONSIDER THE EFFECT THAT THE CHANGE IN THE FEE OR CHARGE

21 REGULAR SESSION OF THE SIXTY-EIGHTH GENERAL ASSEMBLY, BUT ON OR
22 BY FEBRUARY 29, 2012, THE EXECUTIVE DIRECTOR SHALL REPORT TO THE
23 JOINT HOUSE AGRICULTURE, LIVESTOCK, AND NATURAL RESOURCES
24 COMMITTEE AND THE SENATE AGRICULTURE, NATURAL RESOURCES, AND
