After consideration on the merits, the Committee recommends the following:

HB12-1013 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

- 1 Amend printed bill, page 3, after line 15, insert:
2 "(c) IF A SCHOOL DISTRICT BOARD OF EDUCATION ADOPTS
3 PROCEDURES PURSUANT TO THIS SUBSECTION (2), THE SCHOOL DISTRICT
4 SHALL NOTIFY A STUDENT'S PARENTS AS SOON AS POSSIBLE AFTER THE
5 SCHOOL DISTRICT IDENTIFIES THE STUDENT AS BEING AT GREATER RISK OF
6 DROPPING OUT OF SCHOOL. THE SCHOOL DISTRICT SHALL PROVIDE TO THE
7 STUDENT'S PARENTS A DESCRIPTION OF THE INTERVENTIONS THAT THE
8 SCHOOL DISTRICT INTENDS TO IMPLEMENT FOR THE STUDENT, IF ANY. THE
9 PARENT MAY APPROVE OR REJECT THE DESCRIBED INTERVENTIONS. IF THE
10 PARENT REJECTS THE INTERVENTIONS, THE SCHOOL DISTRICT SHALL NOT
11 IMPLEMENT THE INTERVENTIONS. THE PARENT MAY TERMINATE THE
12 INTERVENTIONS AT ANY TIME AFTER THE SCHOOL DISTRICT BEGINS
13 PROVIDING THE INTERVENTIONS.
14 (d) A PARENT MAY CONTACT THE SCHOOL DISTRICT IN WHICH HIS
15 OR HER STUDENT IS ENROLLED TO REQUEST INTERVENTIONS PURSUANT TO
16 THIS SUBSECTION (2) IF THE PARENT DETERMINES THAT THE STUDENT IS AT
17 GREATER RISK OF DROPPING OUT OF SCHOOL."
- 18 Page 4, after line 8, insert:
19 "(3) IF AN INSTITUTE CHARTER SCHOOL ADOPTS PROCEDURES
20 PURSUANT TO THIS SECTION, THE INSTITUTE CHARTER SCHOOL SHALL
21 NOTIFY A STUDENT'S PARENTS AS SOON AS POSSIBLE AFTER THE INSTITUTE
22 CHARTER SCHOOL IDENTIFIES THE STUDENT AS BEING AT GREATER RISK OF
23 DROPPING OUT OF SCHOOL. THE INSTITUTE CHARTER SCHOOL SHALL

1 PROVIDE TO THE STUDENT'S PARENTS A DESCRIPTION OF THE
2 INTERVENTIONS THAT THE INSTITUTE CHARTER SCHOOL INTENDS TO
3 IMPLEMENT FOR THE STUDENT, IF ANY. THE PARENT MAY APPROVE OR
4 REJECT THE DESCRIBED INTERVENTIONS. IF THE PARENT REJECTS THE
5 INTERVENTIONS, THE INSTITUTE CHARTER SCHOOL SHALL NOT IMPLEMENT
6 THE INTERVENTIONS. THE PARENT MAY TERMINATE THE INTERVENTIONS
7 AT ANY TIME AFTER THE INSTITUTE CHARTER SCHOOL BEGINS PROVIDING
8 THE INTERVENTIONS.

9 (4) A PARENT MAY CONTACT THE INSTITUTE CHARTER SCHOOL IN
10 WHICH HIS OR HER STUDENT IS ENROLLED TO REQUEST INTERVENTIONS
11 PURSUANT TO THIS SECTION IF THE PARENT DETERMINES THAT THE
12 STUDENT IS AT GREATER RISK OF DROPPING OUT OF SCHOOL."
