4 (b.7) (I) ANY MATERIAL, COMPOUND, MIXTURE, OR PREPARATION
5 WEIGHING EIGHT HUNDRED MILLIGRAMS OR LESS THAT CONTAINS ANY
6 QUANTITY OF KETAMINE, COMMITS A CLASS 1 MISDEMEANOR.

7 (II) ANY MATERIAL, COMPOUND, MIXTURE, OR PREPARATION
8 WEIGHING MORE THAN EIGHT HUNDRED MILLIGRAMS THAT CONTAINS ANY
9 QUANTITY OF KETAMINE, COMMITS A CLASS 6 FELONY."
