HOUSE COMMITTEE OF REFERENCE AMENDMENT  
 Committee on Business, Labor, Economic, & Workforce Development.  
SB13-259 be amended as follows:

1 Amend reengrossed bill, page 7, line 17, after "add" insert  
 2 "12-58.5-106.5 and".

3 Page 9, before line 14 insert:

4           **"12-58.5-106.5. Advisory committee - creation - membership**  
 5 **- repeal.** (1) THE DIRECTOR SHALL APPOINT AN ADVISORY COMMITTEE  
 6 CONSISTING OF FIVE MEMBERS TO MAKE RECOMMENDATIONS TO THE  
 7 DIRECTOR CONCERNING THE REGULATION OF PRIVATE INVESTIGATORS.  
 8 THE DIRECTOR SHALL APPOINT THREE LICENSED PRIVATE INVESTIGATORS,  
 9 ONE PERSON REPRESENTING LAW ENFORCEMENT, AND ONE PERSON  
 10 REPRESENTING THE PUBLIC TO SERVE ON THE ADVISORY COMMITTEE. THE  
 11 DIRECTOR MAY ESTABLISH, BY RULE, THE TERMS OF OFFICE OF ADVISORY  
 12 COMMITTEE MEMBERS.

13           (2) MEMBERS OF THE ADVISORY COMMITTEE SERVE AT THE  
 14 REQUEST AND PLEASURE OF THE DIRECTOR AND SHALL BE COMPENSATED  
 15 FOR THEIR SERVICES IN ACCORDANCE WITH SECTION 24-34-102 (13),  
 16 C.R.S.

17           (3) THIS SECTION IS REPEALED, EFFECTIVE SEPTEMBER 1, 2016.  
 18 PRIOR TO THE REPEAL, THE DEPARTMENT OF REGULATORY AGENCIES  
 19 SHALL REVIEW THE FUNCTIONS OF THE ADVISORY COMMITTEE AS  
 20 PROVIDED IN SECTION 2-3-1203, C.R.S."

21 Page 14, before line 12 insert:

22           **"SECTION 12.** In Colorado Revised Statutes, 2-3-1203, **add** (3)  
 23 (cc.5) as follows:

24           **2-3-1203. Sunset review of advisory committees.** (3) The  
 25 following dates are the dates for which the statutory authorization for the  
 26 designated advisory committees is scheduled for repeal:

27           (cc.5) SEPTEMBER 1, 2016:

28           (I) THE ADVISORY COMMITTEE APPOINTED PURSUANT TO SECTION  
 29 12-58.5-106.5, C.R.S., TO MAKE RECOMMENDATIONS CONCERNING THE  
 30 REGULATION OF PRIVATE INVESTIGATORS;"

31 Renumber succeeding sections accordingly.
