HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Judiciary.

SB13-011 be amended as follows:

1 Amend reengrossed bill, page 18, after line 27 insert:

2 "14-15-119. **Child placement agencies - conscience clause.**

3 (1) TO THE EXTENT ALLOWED BY FEDERAL LAW, A PRIVATE CHILD
4 PLACEMENT AGENCY SHALL NOT BE REQUIRED TO PERFORM, ASSIST,
5 COUNSEL, RECOMMEND, CONSENT TO, REFER, OR PARTICIPATE IN ANY
6 PLACEMENT OF A CHILD FOR FOSTER CARE OR ADOPTION WHEN THE
7 PROPOSED PLACEMENT OF A CHILD WITH PERSONS WHO HAVE ENTERED
8 INTO A CIVIL UNION WOULD VIOLATE THE AGENCY'S WRITTEN RELIGIOUS
9 OR MORAL CONVICTIONS OR POLICIES.

10 (2) THE STATE DEPARTMENT OF HUMAN SERVICES SHALL NOT
11 DENY AN APPLICATION FOR AN INITIAL LICENSE OR RENEWAL OF A LICENSE
12 OR REVOKE THE LICENSE OF A PRIVATE CHILD PLACEMENT AGENCY
13 BECAUSE OF THE CHILD PLACEMENT AGENCY'S OBJECTION TO PERFORMING,
14 ASSISTING, COUNSELING, RECOMMENDING, CONSENTING TO, REFERRING,
15 OR PARTICIPATING IN A PLACEMENT WITH PARTNERS TO A CIVIL UNION
16 BECAUSE THAT VIOLATES THE AGENCY'S WRITTEN RELIGIOUS OR MORAL
17 CONVICTIONS OR POLICIES.

18 (3) THE STATE DEPARTMENT OF HUMAN SERVICES OR A COUNTY
19 DEPARTMENT OF SOCIAL SERVICES SHALL NOT DENY A PRIVATE CHILD
20 PLACEMENT AGENCY ANY GRANT, CONTRACT, OR PARTICIPATION IN A
21 GOVERNMENT PROGRAM BECAUSE OF THE AGENCY'S OBJECTION TO
22 PERFORMING, ASSISTING, COUNSELING, RECOMMENDING, CONSENTING TO,
23 REFERRING, OR PARTICIPATING IN A PLACEMENT WITH PARTNERS TO A
24 CIVIL UNION BECAUSE THAT VIOLATES THE AGENCY'S WRITTEN RELIGIOUS
25 OR MORAL CONVICTIONS OR POLICIES.

26 (4) THE REFUSAL OF A PRIVATE CHILD PLACEMENT AGENCY TO
27 PERFORM, ASSIST, COUNSEL, RECOMMEND, CONSENT TO, REFER, OR
28 PARTICIPATE IN A PLACEMENT WITH PARTNERS TO A CIVIL UNION BECAUSE
29 THAT VIOLATES THE AGENCY'S WRITTEN RELIGIOUS OR MORAL
30 CONVICTIONS OR POLICIES SHALL NOT FORM THE BASIS OF ANY CLAIM FOR
31 DAMAGES."
