

Amendment L004

Adds non-profit institutions who are already exempt for Business Personal Property taxes. It points to statute for specific exemptions.

These include:

- Religious institutions
- Not for profit schools
- Residential part of Religious institutions
- Fraternal or Veteran organizations
- Public Health care
- Orphanage or low-income senior housing or disabled Housing
