- 4 "(4) (a) This section does not apply to towers or poles that 5 SUPPORT ELECTRIC UTILITY TRANSMISSION LINES OR DISTRIBUTION LINES; 6 TO FACILITIES LICENSED BY THE FEDERAL COMMUNICATIONS COMMISSION 7 OR ANY STRUCTURE WITH THE PRIMARY PURPOSE OF SUPPORTING 8 TELECOMMUNICATIONS EQUIPMENT, INCLUDING MICROWAVE RELAY 9 FACILITIES AND TOWERS ERECTED FOR THE PURPOSE OF PROVIDING 10 COMMERCIAL MOBILE RADIO SERVICE OR COMMERCIAL MOBILE DATA 11 SERVICE AS DEFINED IN 47 CFR 20.3; TO TOWERS WITHIN A SKI AREA 12 BOUNDARY; TO WIND-POWERED ELECTRICAL GENERATORS WITH A ROTOR 13 BLADE RADIUS GREATER THAN SIX FEET; OR TO STREET LIGHTS ERECTED 14 OR MAINTAINED BY THE DEPARTMENT OF TRANSPORTATION.
- 15 (b) NOTWITHSTANDING PARAGRAPH (a) OF THIS SUBSECTION (4), 16 THIS SECTION APPLIES TO PRIVATE MOBILE RADIO SERVICES OTHER THAN 17 COMMERCIAL MOBILE DATA SERVICE AS DEFINED IN 47 CFR 20.3.".
- 18 Renumber succeeding subsection accordingly.
