HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Transportation & Energy.

HB14-1216 be amended as follows:

1 Amend printed bill, page 3, line 21, strike "ANCHORS" and substitute  
2 "ANCHORS, IS SMALLER THAN SIX FEET IN DIAMETER AT THE BASE,".

3 Page 4, after line 21 insert:

4           "(4) (a) THIS SECTION DOES NOT APPLY TO TOWERS OR POLES THAT  
5 SUPPORT ELECTRIC UTILITY TRANSMISSION LINES OR DISTRIBUTION LINES;  
6 TO FACILITIES LICENSED BY THE FEDERAL COMMUNICATIONS COMMISSION  
7 OR ANY STRUCTURE WITH THE PRIMARY PURPOSE OF SUPPORTING  
8 TELECOMMUNICATIONS EQUIPMENT, INCLUDING MICROWAVE RELAY  
9 FACILITIES AND TOWERS ERECTED FOR THE PURPOSE OF PROVIDING  
10 COMMERCIAL MOBILE RADIO SERVICE OR COMMERCIAL MOBILE DATA  
11 SERVICE AS DEFINED IN 47 CFR 20.3; TO TOWERS WITHIN A SKI AREA  
12 BOUNDARY; TO WIND-POWERED ELECTRICAL GENERATORS WITH A ROTOR  
13 BLADE RADIUS GREATER THAN SIX FEET; OR TO STREET LIGHTS ERECTED  
14 OR MAINTAINED BY THE DEPARTMENT OF TRANSPORTATION.

15           (b) NOTWITHSTANDING PARAGRAPH (a) OF THIS SUBSECTION (4),  
16 THIS SECTION APPLIES TO PRIVATE MOBILE RADIO SERVICES OTHER THAN  
17 COMMERCIAL MOBILE DATA SERVICE AS DEFINED IN 47 CFR 20.3."

18 Renumber succeeding subsection accordingly.
