15 YEAR, AND BUDGET YEARS THEREAFTER,".
- 16 Page 19, line 18, strike "THE" and substitute "FOR THE 2017-18 BUDGET
17 YEAR, AND BUDGET YEARS THEREAFTER, THE".
- 18 Page 21, line 5, after "ADJUSTED" insert "IN THE 2017-18 BUDGET YEAR
19 AND IN BUDGET YEARS THEREAFTER,".
- 20 Page 21, line 7, after "ADJUSTED" insert "IN THE 2017-18 BUDGET YEAR
21 AND IN BUDGET YEARS THEREAFTER,".
- 22 Page 21, line 14, after "WITHHELD," insert "IN THE 2017-18 BUDGET YEAR
23 AND IN BUDGET YEARS THEREAFTER,".
- 24 Page 21, line 24, strike "2015-16" and substitute "2016-17".
- 25 Page 22, line 18, strike "2015-16" and substitute "2016-17".

2 YEAR, AND BUDGET YEARS THEREAFTER, IF".

3 Page 29, line 12, strike "CONTRARY:" and substitute "CONTRARY, FOR THE
4 2017-18 BUDGET YEAR, AND BUDGET YEARS THEREAFTER:".

5 Page 31, line 8, after "(o)," insert "(2.5),".

6 Page 33, after line 20, insert:

7 "(2.5)(a) EACH QUALIFYING SCHOOL DISTRICT SHALL PAY TO EACH
8 DISTRICT CHARTER SCHOOL THE AMOUNTS THAT ARE DUE TO EACH
9 DISTRICT CHARTER SCHOOL AS PROVIDED IN THIS SECTION. THE
10 QUALIFYING SCHOOL DISTRICT SHALL PAY THE AMOUNTS IN TWELVE
11 MONTHLY INSTALLMENTS AS SOON AS PRACTICABLE AFTER THE
12 QUALIFYING SCHOOL DISTRICT RECEIVES DISTRIBUTIONS OF MONEYS FROM
13 THE DEPARTMENT PURSUANT TO SECTION 22-54-115.

14 (b) FOR THE 2017-18 BUDGET YEAR, AND BUDGET YEARS
15 THEREAFTER, IF A QUALIFYING SCHOOL DISTRICT'S TOTAL PROGRAM
16 FUNDING IS ADJUSTED MID-YEAR PURSUANT TO SECTION 22-54-112.5 (4),
17 THE QUALIFYING SCHOOL DISTRICT SHALL ADJUST THE DISTRIBUTION TO
18 THE DISTRICT CHARTER SCHOOLS ACCORDINGLY."

19 Page 37, line 12, strike "CONTRARY:" and substitute "CONTRARY, FOR THE
20 2017-18 BUDGET YEAR, AND BUDGET YEARS THEREAFTER:".
