(10)(a) "Policy" means an automobile insurance policy providing coverage for all or any of the following coverages: Collision, comprehensive, bodily injury liability, property damage liability, medical payments, and uninsured motorist coverage, or a combination automobile policy providing bodily injury liability, property damage liability, medical payments, uninsured motorist, and physical damage coverage, delivered or issued for delivery in this state, insuring a single individual, or husband and wife, or family members residing in the same household, as named insured, and under which the insured vehicles therein designated are of the following types only:

(a) (I) A motor vehicle of the private passenger or station wagon type that is not used as a public or livery conveyance for passengers nor rented to others pursuant to the terms of a motor vehicle rental agreement; or

(b) (II) Any other four-wheel motor vehicle with a load capacity of fifteen hundred pounds or less that is not used in the occupation, profession, or business of the insured.

(b) AS USED IN THIS SUBSECTION (10), "LIVERY CONVEYANCE" DOES NOT MEAN THE SERVICES OFFERED BY A TRANSPORTATION NETWORK COMPANY DRIVER, AS THAT TERM IS DEFINED IN SECTION 40-10.1-602 (4), C.R.S., UNLESS THE TRANSPORTATION NETWORK COMPANY DRIVER IS ENGAGED IN A PREARRANGED RIDE, AS THAT TERM IS DEFINED IN SECTION 40-10.1-602 (2), C.R.S."
