HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Local Government.

HB15-1225 be amended as follows:

- 1 Amend printed bill, page 4, after line 25 insert:
 2 "SECTION 3. In Colorado Revised Statutes, 24-32-104, add (2)
 3 as follows:
 4 **24-32-104. Functions of the division.** (2) NO LATER THAN JULY
 5 1, 2015, THE DIVISION SHALL FORMALLY ANNOUNCE, ON ITS WEB SITE AND
 6 BY LETTER TO THE STATE'S LOCAL GOVERNMENTS, AN INITIATIVE FROM
 7 THE LOCAL GOVERNMENT MINERAL IMPACT FUND CREATED IN SECTION
 8 34-63-102 (5), C.R.S., OR THE LOCAL GOVERNMENT SEVERANCE TAX FUND
 9 CREATED IN SECTION 39-29-110, C.R.S., OF ONE MILLION DOLLARS PER
 10 YEAR FOR FIVE YEARS FOR GRANT FUNDING TO LOCAL GOVERNMENTS FOR
 11 PLANNING, ANALYSES, PUBLIC ENGAGEMENT, AND COORDINATION AND
 12 COLLABORATION WITH FEDERAL LAND MANAGERS AND STAKEHOLDERS,
 13 OR FOR SIMILAR OR RELATED LOCAL GOVERNMENT PROCESSES NEEDED BY
 14 LOCAL GOVERNMENTS FOR ENGAGEMENT IN FEDERAL LAND MANAGEMENT
 15 DECISION-MAKING."
- 16 Renumber succeeding sections accordingly.
- 17 Page 4, line 27, strike "portion; and add (5.4) (b) (III)" and substitute
 18 "portion".
- 19 Page 5, strike lines 24 through 27.
- 20 Page 6, strike lines 1 through 6 and substitute:
 21 "SECTION 5. In Colorado Revised Statutes, 39-29-110, add (1)
 22 (b) (V) as follows:
 23 **39-29-110. Local government severance tax fund - creation -**
 24 **administration - definitions.** (1) (b) (V) IN ADDITION TO THE
 25 DISTRIBUTION OF MONEYS AUTHORIZED UNDER SUBPARAGRAPHS (I), (II),
 26 (III), AND (IV) OF THIS PARAGRAPH (b), THE EXECUTIVE DIRECTOR OF THE
 27 DEPARTMENT OF LOCAL AFFAIRS MAY DISTRIBUTE MONEYS FOR PLANNING,
 28 ANALYSES, PUBLIC ENGAGEMENT, AND COORDINATION AND
 29 COLLABORATION WITH FEDERAL LAND MANAGERS AND STAKEHOLDERS,
 30 OR FOR SIMILAR OR RELATED LOCAL GOVERNMENT PROCESSES NEEDED BY
 31 LOCAL GOVERNMENTS FOR ENGAGEMENT IN FEDERAL LAND MANAGEMENT
 32 DECISION-MAKING."
