## HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Finance.HB15-1205 be amended as follows:

- 1 Amend printed bill, page 4, line 17, strike "JULY 1, 2015." and substitute  
2 "JULY 1, 2017."
- 3 Page 6, strike lines 13 through 15.
- 4 Renumber succeeding subparagraphs accordingly.
- 5 Page 6, line 25, strike "MAY" and substitute "SHALL".
- 6 Page 7, line 6, strike "AND".
- 7 Page 7, line 10, strike "GOAL." and substitute "GOAL; AND".
- 8 Page 7, after line 10 insert:
- 9 "(III) WHETHER THERE ARE ANY OPPORTUNITIES TO IMPROVE THE  
10 EFFECTIVENESS OF THE TAX EXPENDITURE IN MEETING ITS PURPOSE,  
11 INTENT, OR GOAL."
- 12 Page 7, strike lines 11 through 27 and substitute:
- 13 "(3) (a) NOTWITHSTANDING THE REQUIREMENTS IN SECTION  
14 2-3-103 (2), THE STATE AUDITOR OR THE EVALUATION CONTRACTOR  
15 SHALL EVALUATE TAX EXPENDITURES AND SUBMIT THE RESULTS OF THE  
16 EVALUATIONS IN AN EVALUATION REPORT TO THE COMMITTEE AS  
17 FOLLOWS:
- 18 (I) NO LATER THAN SEPTEMBER 15, 2017, FOR ANY TAX  
19 EXPENDITURES IN LAW AS OF THE EFFECTIVE DATE OF THIS PARAGRAPH (a)  
20 AND ANY TAX EXPENDITURES ENACTED DURING THE FIRST REGULAR  
21 SESSION OF THE SEVENTIETH GENERAL ASSEMBLY;
- 22 (II) NO LATER THAN SEPTEMBER 15, 2022, AND EACH SEPTEMBER  
23 15 EVERY FIVE YEARS THEREAFTER, FOR A REEVALUATION OF THE TAX  
24 EXPENDITURES EVALUATED IN THE PREVIOUS EVALUATION REPORT AND  
25 AN EVALUATION OF ANY NEW TAX EXPENDITURES ENACTED BY THE  
26 GENERAL ASSEMBLY SINCE THE PREVIOUS EVALUATION REPORT."
- 27 Page 8, strike lines 1 through 10 and substitute:



1           "(b) BY DECEMBER 15, 2017, AND BY DECEMBER 15 EVERY FIVE  
2 YEARS THEREAFTER, THE COMMITTEE SHALL MEET TO CONSIDER THE  
3 EVALUATION REPORT SUBMITTED BY THE STATE AUDITOR OR THE  
4 EVALUATION CONTRACTOR. THE COMMITTEE MUST HOLD A".

5 Page 8, line 13, strike "EVALUATIONS FOR THAT YEAR." and substitute  
6 "EVALUATION REPORT."

7 Page 8, line 16, after "SESSION." add "THE COMMITTEE MAY MEET AS  
8 NECESSARY DURING THE FIVE YEARS BETWEEN THE PRESENTATION OF THE  
9 EVALUATION REPORTS."

10 Page 9, line 4, strike "DATA" and substitute "DATA, IF AVAILABLE AND  
11 UNDER THE CONTROL OF THE DEPARTMENT,"

12 Page 9, line 12, strike "LEGISLATIVE COUNCIL" and after "STAFF" insert  
13 "OF THE STATE AUDITOR".

14 Page 9, line 16, strike "JULY 1, 2025." and substitute "JULY 1, 2028."
