

Collaborating with our partners, our mission is to design and deliver high quality human services and healthcare that improve the safety, independence, and well-being of the people of Colorado.


VISION:





FY 2016-17 CDHS Capital Construction Requests

Capital Construction requested include no new projects
These are continuation projects that:

- · Minimize life safety risk for the medically fragile
- · Address critical safety, security, and suicide risk related needs
- Improve accessibility needs
- Enhance safety and the overall quality of the resident care environment
- Continue the commitment to provide safe and secure living environments
- · All prior phases of these projects are on time and on budget

- 1. Mental Health Institutes Suicide Risk Mitigation, Phase 3 of 5-\$1,867,586
- 2. Division of Youth Corrections Facility Refurbishment for Safety, Risk Mitigation, and Modernization, Phase 3 of 7 \$3,689,500
- 3. Regional Centers Capital Improvements \$979,884 Cash Funded
- 4. Division of Youth Corrections Adams County Youth Services Center Replacement, Phase 2 of 3 \$3,000,000
- Colorado Veterans Community Living Centers Resident Safety, Security, and Accessibility Improvements, Phase 2 of 2 - \$2,278,060

Mental Heath Institutes Suicide Risk Mitigation Phase 3 of 5 (\$1,867,586)

What We Will Do:

- · Removal and replacement of plumbing fixtures in toilets and showers
- Elimination of tie-off points in toilet and shower partitions, suspended grid ceiling, and replacement of light fixtures in patient areas
- Removal and replacement of door hardware, showers, toilets and ventilation system duct covers in patient sleeping rooms
- Bathroom renovation to improve staff visibility and supervision while maintaining a degree of privacy and to provide accessibility per Americans with Disabilities Act around fixtures

Refurbishment for Safety, Risk Mitigation, and Modernization Phase 3 of 7 (\$3,689,500)

What We Will Do:

- · Improvements to Gilliam, Grand Mesa and Adams
- · Renovate sleeping rooms to provide secure barriers
- · Full replacement of all wooden doors
- Self-harm resistant grab bars, showers, and sinks including handles, hinges, sprinkler heads, and faucets
- · Replacement of security electronics system

What We Are Doing:

- Assessment and action plan to mitigate safety concerns
- Addressing immediate and critical needs first such as window grilles, metal detectors, site/perimeter safety improvements, and seclusion room safety improvements




Lookout Mountain Youth Services Center Jumping Risk 2nd Story - Pre-Mitigation



Lookout Mountain Youth Services Center Glass Wall - After Mitigation






What We Will Do:

- Capital improvements to group homes to enhance resident safety by removing slip, trip and fall hazards, and removal of line-of-sight obstructions
- Place 11 emergency generators in homes housing the medically fragile

Adams County Youth Services Center Replacement Phase 2 of 3 (\$3,000,000)


What We Will Do:

- Site development and infrastructure for the replacement facility with an estimated infrastructure completion date of July 2017
 - Infrastructure includes utility taps, roadway access to the site with sidewalks, curbs, and gutters

- Contracted with an Architect/Engineering team to prepare design and construction documents
- Transferred land with Adams County through an Interagency Agreement

What We Will Do:


Fitzsimons
