- 2 "SECTION 3. In Colorado Revised Statutes, add 38-33.3-125 as follows:
 - 38-33.3-125. Unit owners' bill of rights. (1) NOTWITHSTANDING ANY PROVISION OF THIS ARTICLE OR OF THE DECLARATION, BYLAWS, OR RULES AND REGULATIONS OF THE ASSOCIATION TO THE CONTRARY:
 - (a) A UNIT OWNER HAS THE RIGHT TO PURSUE REPAIR OR MAINTAIN AN ACTION FOR DAMAGES TO HIS OR HER PROPERTY RESULTING FROM CONSTRUCTION DEFECTS EVEN IF THE ASSOCIATION OR OTHER UNIT OWNERS ELECT NOT TO PURSUE REPAIR OR MAINTAIN AN ACTION FOR DAMAGES BASED ON THE SAME OR A SIMILAR CONSTRUCTION DEFECT.
 - (b) NO RIGHT OF AN INDIVIDUAL UNIT OWNER CAN BE WAIVED BY THE DEVELOPER, ASSOCIATION, OR ANOTHER UNIT OWNER WITHOUT THE UNIT OWNER'S EXPLICIT CONSENT, OBTAINED WITHOUT DURESS OR COERCION.
 - (c) A UNIT OWNER RETAINS THE RIGHT TO DETERMINE WHO CAN ENTER HIS OR HER PREMISES OR PROVIDE REPAIRS TO HIS OR HER PROPERTY.
 - (d) A UNIT OWNER HAS THE RIGHT TO MAKE CHANGES TO THE INTERIOR OF HIS OR HER HOME WITHOUT HAVING TO SEEK THE PERMISSION OF THE ASSOCIATION, A BUILDER, OR A DEVELOPER; AND
 - (e) A UNIT OWNER OR THE ASSOCIATION MAY RETAIN ANY EXPERT OF THEIR CHOOSING TO HELP UNDERSTAND THE NATURE OF THE DAMAGE, THE COST OF REPAIRS, OR ANY OTHER INFORMATION THAT THE UNIT OWNER OR THE ASSOCIATION NEEDS TO MAKE AN INFORMED CHOICE ABOUT HOW BEST TO PURSUE THEIR PROPERTY RIGHTS AND REMEDIES UNDER COLORADO LAW.".
