- 1 Amend printed bill, page 3, strike line 13 and substitute "county clerk and
- 2 recorder either by mail, or in person, OR ON-LINE IN ACCORDANCE WITH
- 3 SECTION 1-2-202.5. ".
- 4 Page 4, line 4, after "(2)" insert "(a)".
- 5 Page 4, strike line 10 and substitute "THE CANDIDATES OF EACH OF THE
- 6 POLITICAL PARTIES. IF IT IS NOT PRACTICABLE FOR A COUNTY TO USE A
- 7 SINGLE COMBINED BALLOT THAT CONTAINS THE NAMES OF THE
- 8 CANDIDATES OF EACH OF THE POLITICAL PARTIES, THEN THE COUNTY

- 16 PARTY. AN ELECTOR MAY CAST THE BALLOT OF ONLY ONE MAJOR
- 17 POLITICAL PARTY. AFTER SELECTING AND CASTING A BALLOT OF A SINGLE
- 18 MAJOR POLITICAL PARTY, THE ELECTOR SHALL RETURN THE BALLOT TO
- 19 THE CLERK. IF AN ELECTOR CASTS AND RETURNS TO THE CLERK THE
- 20 BALLOT OF MORE THAN ONE MAJOR POLITICAL PARTY, ALL SUCH BALLOTS
- 21 RETURNED WILL BE VOID AND WILL NOT BE COUNTED.
