SB15-173 be amended as follows:

1 Amend proposed committee amendment (SB173_L.003), page 4, line 31,
2 strike "AND".

3 Page 4, line 36, strike "INSTITUTE." and substitute "INSTITUTE;

4 (c) PUBLICLY AND CONSPICUOUSLY POST:

5 (I) THE NAME, CONTACT INFORMATION, AND LOCATION OF ANY
6 DATA REPOSITORY WHERE ANY COVERED INFORMATION WOULD BE
7 MAINTAINED BY THE OPERATOR, SERVICE PROVIDER, OR OTHER THIRD
8 PARTY TO WHOM THE OPERATOR DISCLOSED THE COVERED INFORMATION;

9 (II) THE PRINCIPAL PURPOSE OR PURPOSES FOR WHICH THE
10 COVERED INFORMATION IS INTENDED TO BE USED;

11 (III) A DATA DICTIONARY OF THE COVERED INFORMATION OR ANY
12 OTHER INFORMATION THAT IS COLLECTED OR MAINTAINED BY THE
13 OPERATOR, SERVICE PROVIDER, OR OTHER THIRD PARTY TO WHOM THE
14 OPERATOR DISCLOSED COVERED INFORMATION;

15 (IV) THE PROCESS BY WHICH COVERED INFORMATION IS
16 COLLECTED;

17 (V) THE OPERATOR'S POLICIES AND PRACTICES REGARDING
18 STORAGE, RETRIEVABILITY, ACCESS CONTROLS, RETENTION, AND DISPOSAL
19 OF COVERED INFORMATION;

20 (VI) DATE OF ANY TRANSFER, MERGE, OR SHARE OF COVERED
21 INFORMATION; AND

22 (VII) THE NAME AND CONTACT INFORMATION OF THE SOURCE AND
23 CONTENTS OF ANY DATA SETS MERGED WITH ANY COVERED INFORMATION
24 MAINTAINED BY THE OPERATOR; AND

25 (d) RETAIN PERSONAL INFORMATION COLLECTED ON-LINE FROM A
26 STUDENT FOR ONLY AS LONG AS IS REASONABLY NECESSARY TO FULFILL
27 THE PURPOSE FOR WHICH THE INFORMATION WAS COLLECTED, BUT IN NO
28 INSTANCE LONGER THAN THREE YEARS. THE OPERATOR SHALL DELETE
29 SUCH INFORMATION USING REASONABLE MEASURES TO PROTECT AGAINST
30 UNAUTHORIZED ACCESS TO OR USE OF THE INFORMATION IN CONNECTION
31 WITH ITS DELETION."
