## HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Education.HB15-1323 be amended as follows:

1 Amend printed bill, page 13, line 18, after "(6)" insert "and (7)".

2 Page 14, after line 6 insert:

3           "(7) (a) EACH LOCAL EDUCATION PROVIDER SHALL ADOPT AND  
4 IMPLEMENT PROCEDURES BY WHICH THE LOCAL EDUCATION PROVIDER, OR  
5 THE PUBLIC SCHOOLS THAT THE LOCAL EDUCATION PROVIDER OPERATES,  
6 SHALL ANNUALLY DISTRIBUTE TO THE PARENTS OF STUDENTS ENROLLED  
7 BY THE LOCAL EDUCATION PROVIDER AN ASSESSMENT CALENDAR. AT A  
8 MINIMUM, THE ASSESSMENT CALENDAR MUST SPECIFY THE ESTIMATED  
9 HOURS EACH TESTING DAY THAT SPECIFIC CLASSES OR GRADES WILL TAKE  
10 EACH ASSESSMENT AND IDENTIFY WHETHER THE ASSESSMENT IS REQUIRED  
11 BY FEDERAL LAW OR STATE LAW OR SELECTED BY THE LOCAL EDUCATION  
12 PROVIDER. THE PROCEDURES SHALL SPECIFY THE TIMING FOR  
13 DISTRIBUTION OF THE CALENDAR AND REQUIRE THAT THE CALENDAR IS  
14 DISTRIBUTED TO PARENTS AND POSTED ON THE LOCAL EDUCATION  
15 PROVIDER'S WEB SITE.

16           (b) (I) IN ADDITION TO THE CALENDAR DESCRIBED IN PARAGRAPH  
17 (a) OF THIS SUBSECTION (7), EACH LOCAL EDUCATION PROVIDER SHALL  
18 PROVIDE WRITTEN INFORMATION TO THE PARENTS OF STUDENTS ENROLLED  
19 BY THE LOCAL EDUCATION PROVIDER THAT DESCRIBES:

20           (A) THE STATE AND LOCAL ASSESSMENTS THAT THE LOCAL  
21 EDUCATION PROVIDER WILL ADMINISTER DURING THE SCHOOL YEAR,  
22 IDENTIFYING THE ASSESSMENTS THAT THE LOCAL EDUCATION PROVIDER  
23 IS REQUIRED BY FEDERAL LAW TO ADMINISTER, ANY ADDITIONAL STATE  
24 ASSESSMENTS THAT THE LOCAL EDUCATION PROVIDER IS REQUIRED BY  
25 SECTION 22-7-1006.3 TO ADMINISTER, THE ASSESSMENTS THAT THE LOCAL  
26 EDUCATION PROVIDER IS REQUIRED BY OTHER STATE LAW TO ADMINISTER,  
27 AND THE ADDITIONAL ASSESSMENTS THAT THE LOCAL EDUCATION  
28 PROVIDER CHOOSES TO ADMINISTER;

29           (B) THE ANTICIPATED CALENDAR FOR ADMINISTERING THE STATE  
30 AND LOCAL ASSESSMENTS DURING THE SCHOOL YEAR; AND

31           (C) THE PURPOSES OF THE STATE ASSESSMENTS ADMINISTERED  
32 PURSUANT TO SECTION 22-7-1006.3 AND ANY ADDITIONAL LOCAL  
33 ASSESSMENTS THAT THE LOCAL EDUCATION PROVIDER ADMINISTERS AND  
34 THE MANNER IN WHICH THE DEPARTMENT OF EDUCATION AND THE LOCAL  
35 EDUCATION PROVIDER USES THE ASSESSMENT RESULTS.

36           (II) EACH LOCAL EDUCATION PROVIDER SHALL ANNUALLY



1 DISTRIBUTE THE WRITTEN INFORMATION TO PARENTS AS EARLY IN THE  
2 SCHOOL YEAR AS POSSIBLE AND SHALL POST THE WRITTEN INFORMATION  
3 ON THE LOCAL EDUCATION PROVIDER'S WEB SITE.

4 (c) THE PROVISIONS OF THIS SUBSECTION (7) DO NOT APPLY TO  
5 COURSE-SPECIFIC ASSESSMENTS THAT ARE NOT ADOPTED BY THE STATE  
6 BOARD PURSUANT TO SECTION 22-7-1006 OR TO NONSTANDARDIZED,  
7 CLASSROOM-BASED ASSESSMENTS THAT INDIVIDUAL EDUCATORS CHOOSE  
8 TO ADMINISTER TO STUDENTS."
