HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Education.SB15-214 be amended as follows:

1 Amend reengrossed bill, page 3, line 20, strike "SIX" and substitute
2 "ELEVEN".

3 Page 4, line 9, strike "AND".

4 Page, 4, line 12, strike "GOVERNOR." and substitute "GOVERNOR; AND".

5 Page 4, after line 12 insert:

6 "(VII) ONE MEMBER WHO IS A SCHOOL SAFETY AND SECURITY
7 DIRECTOR WITH SUBJECT MATTER EXPERTISE IN PHYSICAL PLANT
8 SECURITY, SAFETY-RELATED TECHNOLOGY, THREAT ASSESSMENT, AND
9 EARLY DETECTION AND RESPONSE TO DANGEROUS SITUATIONS IN SCHOOL
10 SETTINGS, TO BE APPOINTED BY THE GOVERNOR;

11 (VIII) ONE MEMBER WHO REPRESENTS A RESEARCH PROGRAM
12 THAT PROVIDES INFORMED ASSISTANCE TO GROUPS COMMITTED TO
13 UNDERSTANDING AND PREVENTING VIOLENCE, PARTICULARLY
14 ADOLESCENT VIOLENCE, TO BE APPOINTED BY THE GOVERNOR;

15 (IX) ONE MEMBER WHO IS A LICENSED PSYCHOLOGIST OR
16 PSYCHIATRIST WITH EXPERIENCE TREATING ADOLESCENTS IN CRISIS, TO BE
17 APPOINTED BY THE GOVERNOR;

18 (X) ONE MEMBER WHO IS AN ATTORNEY WHO IS LICENSED IN
19 COLORADO AND WHO HAS EXPERIENCE WITH THE FEDERAL "FAMILY
20 EDUCATIONAL RIGHTS AND PRIVACY ACT OF 1974", AS AMENDED, 20
21 U.S.C. SEC. 1232g, WITH SPECIAL EDUCATION REGULATIONS, AND WITH
22 EDUCATION LAW, TO BE APPOINTED BY THE GOVERNOR; AND

23 (XI) ONE MEMBER WHO IS A LICENSED SPECIAL EDUCATION
24 ADMINISTRATOR WHO HAS EXPERIENCE WORKING WITH STUDENTS WITH
25 DISABILITIES AND WHO HAS KNOWLEDGE OF MENTAL HEALTH SUPPORTS IN
26 PUBLIC SCHOOLS, TO BE APPOINTED BY THE GOVERNOR."
