Section 33-1-105 (3)(a), C.R.S. states:

In the event that the [Parks and Wildlife] Commission plans to acquire the fee title to any real property or to acquire an easement for a period to exceed 25 years or at a cost to exceed \$100,000 or to enter into any lease agreement for the use of real property for a period to exceed 25 years or at a cost to exceed \$100,000, or to sell or otherwise dispose of the fee title to any real property which has a market value in excess of \$100,000, the Commission shall first submit a report to the Capital Development Committee [CDC] which outlines the anticipated use of the real property, the maintenance costs related to the property, the current value of the property, any conditions or limitations which may restrict the use of the property, and, in the event real property is acquired, the potential liability to the state which will result from such acquisition. The CDC shall review the reports submitted by the Commission and make recommendations to the Commission concerning the proposed land transaction within 30 days from the day on which the report is received. The Commission shall not complete such transactions without considering the recommendations of the CDC, if such recommendations are timely made.

The required report is attached. CDC staff questions about the report are listed below.

Action Required

Recommend support for the fee title acquisition of the Rio Blanco Lake State Wildlife Area White River Investments LLC Fee Title Acquisition (\$0 for 39.21 acres).

CDC Staff Notes

1. Why does White River City Investments, LLC, no longer wish to develop the property for gravelling operations?

CPW does not know why the landowner does not want to develop a gravelling operation on the property; the landowner has not shared this information with us.

2. Why does the landowner require that the transaction close in 2015?

We believe this transaction is driven by tax considerations on the part of the landowner. He has stated that he will not offer this property to CPW in 2016.

Summary of Proposal: White River City Investments, LLC has approached CPW regarding the conveyance, for no monetary consideration, of fee title to 39.21 acres of undeveloped land. This property is adjacent to the existing Rio Blanco Lake SWA and acquisition of it would extend public access on both sides of the White River. This property, which is riparian river corridor, would provide additional fishing and small game and waterfowl hunting and protected habitat for a number of species.

In order to accommodate the landowner's condition that this transaction close in 2015, this proposal is being presented to the CDC prior to its final presentation to the Colorado Parks and Wildlife Commission. The project will be presented to the Parks and Wildlife Commission

on November 20, 2015. Otherwise, it would be impossible to close this calendar year and the landowner's offer will be withdrawn.

Additional information:

- Current use and proposed future use. The property is an undeveloped portion of a gravelling operation on the south side of the White River. Its future use will be as an extension of the riparian habitat protection at Rio Blanco Lake SWA and public access for fishing and small game and waterfowl hunting.
- Date landowner purchased the Property: 2013.

Renewable Resources:

According to a review of the first map referenced below, the Property lies outside the scope of regions of known or potential geothermal resources. According to a review of the second map referenced below, the Property lies outside the Central Solar Power and the Wind Resource Generation Development areas.

<u>Geothermal</u>: November, 2003 US Department of Energy, Office of Energy Efficiency and Renewable Energy, Geothermal Technologies Program.



Mineral Interest Ownership:

Surface ownership, including the right to extract sand and gravel, will be transferred to CPW. Oil, gas and other mineral rights were severed from the surface ownership in the 1920s. Because the property borders both sides of the White River, it is unlikely removal of any subsurface minerals (i.e. oil or gas) from the surface of the property would be approved by the State or County.


