Description: The committee is comprised of five members, no more than three of whom may be from the same political party. The members are: one assessor and one non-assessor from counties of 75,000 or more population; one assessor and one non-assessor from counties of less than 75,000 population; and one non-assessor from the western slope. The governor appoints one of the non-assessors as chairman. The governor appoints the assessor members from among the certified assessors recommended by the Colorado Assessors Association. Requires Senate confirmation. Per diem compensation may not exceed thirty days in any calendar year.

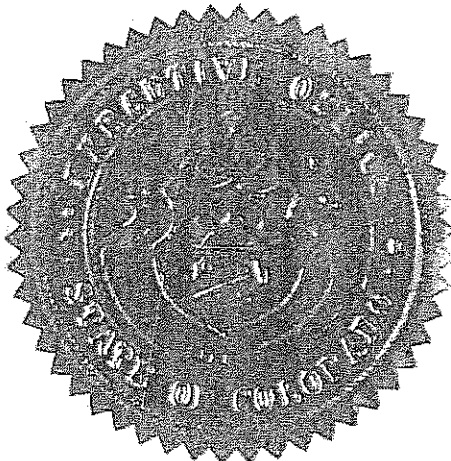
