INTERIM COMMITTEE AMENDMENT

Committee on Profiling - Initiated Contacts by Law Enforcement

LLS No. 16-0335 be amended as follows:

- 1 Amend LLS No. 16-0335, page 2, line 9, strike "REVENUE" and substitute
- 2 "REVENUE, OFFICE OF INFORMATION TECHNOLOGY, A STATEWIDE
- 3 ASSOCIATION OF CHIEFS OF POLICE,".

- 4 Page 2, line 13, after the period, insert "THE COLORADO STATE PATROL'S
- 5 PARTICIPATION IN THE PILOT PROJECT SHALL BE LIMITED TO A RURAL,
- 6 MOUNTAIN, AND URBAN TROOP SELECTED BY THE EXECUTIVE DIRECTOR.
- 7 THE EXECUTIVE DIRECTOR SHALL SELECT TROOPS ENSURING THAT NONE
- 8 OF THE TROOPS SELECTED HAVE JURISDICTION OVER THE SAME JUDICIAL
- 9 DISTRICT.".

- 10 Page 3, line 10, after "STRIP" insert "OR BAR CODE".

- 11 Page 3, line 11, strike "OR" and substitute "AND".

- 12 Page 3, strike lines 20 and 21 and substitute "INCLUDING HARDWARE,
- 13 SOFTWARE, INTERFACES, AND TRAINING.".

- 14 Page 3, line 27, strike "OR" and substitute "AND".

- 15 Page 4, line 1, strike "OR" and substitute "AND".

- 16 Page 4, line 5, strike "REVENUE" and substitute "REVENUE, OFFICE OF
- 17 INFORMATION TECHNOLOGY, A STATEWIDE ASSOCIATION OF CHIEFS OF
- 18 POLICE,".

- 19 Page 5, strike lines 3 and 4.

- 20 Page 5, line 5, strike "TRAINING BOARD".

- 21 Page 5, line 7, strike "PEACE OFFICERS STANDARDS AND TRAINING BOARD"
- 22 and substitute "DIVISION".

- 23 Page 5, line 19, after the period, insert "THE DIVISION SHALL ESTABLISH
- 24 BENCHMARKS FOR THE DATA PRIOR TO PREPARING THE INITIAL REPORT.".

- 25 Page 6, line 14, strike the first "OR" and substitute "AND" and strike the
- 26 second "OR" and substitute "AND".

- 27 Page 6, line 27, strike "OR" and substitute "AND".

- 1 Page 7, line 8, strike "OR" and substitute "AND".
- 2 Page 7, line 9, strike "OR" and substitute "AND".
- 3 Page 7, line 22, strike "OR" and substitute "AND".
