3 (5) (g), (5) (j), (5) (k), (5) (m), (5) (n), (5) (o), (5) (p), (5) (r), (5) (s), (5)  
4 (t), (5) (u), (5) (v), (5) (w), (5) (x), (5) (y), (5) (z), (5) (cc), (5) (dd), and  
5 (8); **repeal** (2) (g), (3) (a), (3) (b), (5) (bb), (9), and (10); and **add** (2)  
6 (e.5), (5) (ee), (5) (ff), (5) (gg), (5) (hh), (5.5),".

8 "(b) "Cash fund" means any fund, other than the state general fund  
9 created by section 24-75-201 and any federal fund, THAT IS established by  
10 law for a specific program or purpose AND THAT INCLUDES MONEYS FROM  
11 FEES."

12 Page 3, after line 22 insert:

13 "(V) Any moneys received from charges or assessments, the  
14 amount of which are ESTABLISHED IN LAW AND OVER WHICH THE ENTITY  
15 HAS NO AUTHORITY TO CHANGE OR ARE OTHERWISE not determined by the  
16 entity;".

- 16 Renumber succeeding sections accordingly.
- 17 Page 19, strike lines 16 through 27 and substitute:  
18 "SECTION 12. Applicability. This act applies to fiscal years  
19 beginning on or after July 1, 2014.  
20 SECTION 13. Safety clause. The general assembly hereby finds,  
21 determines, and declares that this act is necessary for the immediate  
22 preservation of the public peace, health, and safety."
