Committee on Health, Insurance, & Environment.HB15-1191 be amended as follows:

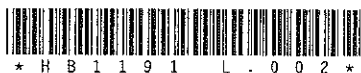
- 1 Amend printed bill, page 2, strike lines 5 and 6 and substitute "cited as

- 4 substitute "physicians AND DENTISTS;".
- 5 Page 2, line 14, strike "~~Physician~~ HEALTH CARE PROVIDER" and substitute
- 6 "Physician AND DENTIST".

  - 17 challenge and correct erroneous designations, data, and methodologies;

  - 19 physicians AND DENTISTS are designated will encourage, to the".

6 substitute "physician's OR DENTIST'S".
- 7 Page 8, line 8, strike "~~physician's~~ HEALTH CARE PROVIDER'S" and  
8 substitute "physician's OR DENTIST'S".
- 9 Page 8, lines 12 and 13, strike "~~physician~~ HEALTH CARE PROVIDER" and  
10 substitute "physician OR DENTIST".
