- 18 AND SHALL NOT BE SUBJECT TO THE "COLORADO OPEN RECORDS ACT",
- 19 PART 2 OF ARTICLE 72 OF TITLE 24, C.R.S.
- 20 (c) Information, records, reports, communications, notes,
- 21 AND MEMORANDA THAT ARE CONFIDENTIAL PURSUANT TO PARAGRAPHS
- 22 (a) AND (b) OF THIS SUBSECTION (2) ARE NOT SUBJECT TO SUBPOENA,
- 23 DISCOVERY, OR INTRODUCTION INTO EVIDENCE IN ANY CIVIL OR CRIMINAL
- 24 PROCEEDING, UNLESS THE SUBPOENA IS DIRECTED TO A SOURCE THAT IS
- 25 SEPARATE AND APART FROM THE COMMITTEE. NOTHING IN THIS SECTION
- 26 IS CONSTRUED TO LIMIT OR RESTRICT THE RIGHT TO DISCOVER OR USE IN
- 27 A CIVIL OR CRIMINAL PROCEEDING INFORMATION, RECORDS, REPORTS,
- 28 COMMUNICATIONS, NOTES, OR MEMORANDA THAT ARE AVAILABLE FROM
- 29 ANOTHER SOURCE SEPARATE AND APART FROM THE COMMITTEE AND THAT
- 30 ARISE ENTIRELY INDEPENDENTLY OF THE COMMITTEE'S ACTIVITIES.".

- Page 7, lines 25 and 26, strike "MEMORANDA, OR OTHER DATA COLLECTED

- 2 CONFIDENTIAL PURSUANT TO PARAGRAPHS (a) AND (b) OF THIS

3 SUBSECTION (2)".
