HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Judiciary.SB15-182 be amended as follows:

1 Amend reengrossed bill, page 2, after line 24, insert:

2 "(IV) (A) THE DEPARTMENT OF CORRECTIONS SHALL DEVELOP
3 POLICIES AND PROCEDURES FOR DECISION-MAKING REGARDING THE
4 TRANSFER OF ANY OFFENDER NOT SENTENCED TO THE YOUTHFUL
5 OFFENDER SYSTEM INTO THE YOUTHFUL OFFENDER SYSTEM IN ORDER TO
6 ENSURE THAT THE GOALS OF THE YOUTHFUL OFFENDER SYSTEM, AS
7 DESCRIBED IN THIS SECTION; THE OPERATIONS OF THE REHABILITATIVE
8 PROGRAM WITHIN THE YOUTHFUL OFFENDER SYSTEM; AND THE DELIVERY
9 OF SERVICES TO THOSE OFFENDERS DIRECTLY SENTENCED TO THE
10 YOUTHFUL OFFENDER SYSTEM ARE NOT COMPROMISED IN ANY WAY BY THE
11 COMINGLED POPULATION.

12 (B) THE DEPARTMENT OF CORRECTIONS SHALL INCLUDE IN ITS
13 ANNUAL REPORT TO THE JUDICIARY COMMITTEES OF THE HOUSE OF
14 REPRESENTATIVES AND SENATE, OR TO ANY SUCCESSOR COMMITTEES,
15 PURSUANT TO SECTION 2-7-203, C.R.S., AND IN ANY ANNUAL YOUTHFUL
16 OFFENDER SYSTEM REPORT PRODUCED BY THE DEPARTMENT,
17 INFORMATION REGARDING THE POLICIES AND PROCEDURES DEVELOPED BY
18 THE DEPARTMENT PURSUANT TO SUB-SUBPARAGRAPH (A) OF THIS
19 SUBPARAGRAPH (IV), THE CHARACTERISTICS OF THE POPULATION OF
20 YOUTHFUL OFFENDERS TRANSFERRED PURSUANT TO THIS PARAGRAPH (c),
21 AND THE IMPACT, IF ANY, OF TRANSFERRED INMATES ON ANY YOUTHFUL
22 OFFENDER SYSTEM PROGRAMMING OR DEPARTMENT OF CORRECTIONS
23 PROGRAMMING.

24 (C) NOTWITHSTANDING ANY PROVISIONS OF THIS SECTION TO THE
25 CONTRARY, THE DEPARTMENT OF CORRECTIONS SHALL NOT INITIATE ANY
26 TRANSFERS OF INMATES TO THE YOUTHFUL OFFENDER SYSTEM UNTIL THE
27 DEPARTMENT HAS DEVELOPED THE POLICIES AND PROCEDURES DESCRIBED
28 IN SUB-SUBPARAGRAPH (A) OF THIS SUBPARAGRAPH (IV)."
