22 CONSTRUCTION FUND FOR THE IMPLEMENTATION OF THE INVASIVE  
23 PHREATOPHYTE CONTROL PROGRAM CREATED IN SECTION 37-60-131,  
24 C.R.S., FOR THE TWO FISCAL YEARS COMMENCING ON JULY 1, 2015, TWO  
25 MILLION DOLLARS; EXCEPT THAT, FOR THE FISCAL YEAR COMMENCING ON  
26 JULY 1, 2016, THE STATE TREASURER SHALL NOT TRANSFER ANY MONEYS  
27 TO THE COLORADO WATER CONSERVATION BOARD CONSTRUCTION FUND  
28 UNDER THIS PARAGRAPH (o) IF THE PROPORTIONAL REDUCTION SET FORTH  
29 IN PARAGRAPH (b) OF SUBSECTION (4) OF THIS SECTION IS TRIGGERED FOR  
30 THE OTHER TRANSFERS LISTED IN THIS SUBSECTION (2).".
