SUBJECT: FY 2016-17 Capital Construction Requests and Projected Available Revenue

Summary

This memorandum provides an overview of projected revenue available in FY 2016-17 for capital construction and controlled maintenance projects. It also summarizes the capital construction requests for FY 2016-17. Table 2 provides an overview of projected revenue versus requests for capital projects in FY 2016-17. Table 2 shows a \$300.0 million revenue shortfall to fund all capital requests.

Revenue

As of December 1, 2015, there is projected to be about \$114.3 million available for FY 2016-17 capital construction projects from the Capital Construction Fund (CCF). Of this amount, \$4.3 million comes from the uncommitted fund balance from prior fiscal years. Additional funds come from projected CCF interest earnings in FY 2015-16. In addition, there is projected to be about \$1.5 million available from unspent interest earnings on the Controlled Maintenance Trust Fund. In a November 2, 2015, letter to the Capital Development Committee (CDC), the Governor's Office of State Planning and Budgeting (OSPB) recommended a FY 2016-17 General Fund transfer of \$58.5 million to fund capital and information technology projects for FY 2016-17. Once this number is adjusted to exclude information technology requests under consideration by the Joint Technology Committee and certain technical adjustments, the FY 2016-17 General Fund transfer amount required to fully fund the capital projects recommended by OSPB is \$54.8 million.

Requests

State-funded requests. As of November 2, 2015, there are 39 state-funded capital construction requests for FY 2016-17, including 14 from state departments and 25 from higher education institutions. In addition, there are 119 state-funded controlled maintenance projects requested for funding. Table 1, beginning on the next page, lists the number of projects, by

type, and the associated total request amounts. This year's capital budget request does not include any certificates of participation (COP) lease payments.

In a letter dated November 2, 2015, OSPB recommended funding 13 state-funded projects for FY 2016-17, including part of the Level 1 Controlled Maintenance project list (\$10.2 million), 11 continuation projects, and the ongoing \$500,000 General Fund Exempt Account appropriation for unspecified highway construction projects. Of these 13 projects, one is requested from cash funds but categorized as a state-funded request because it received prior state funding.

Cash-funded requests. In addition to the 39 state-funded projects and 119 state-funded controlled maintenance projects requested for FY 2016-17, there are 10 cash-funded requests. Higher education cash-funded requests are submitted separately, and are not calculated in the FY 2016-17 total cash-funded request amounts. The total cash funds requested for all projects is \$150.0 million. The total cash funds request amount for projects funded solely from cash sources, excluding the cash component of the various state-funded requests, is \$39.2 million.
