Dear Colorado Health and Human Services Committee,

My name is Allan E. Parker and I am the president of The Justice Foundation. The attached documents are legally admissible evidence from Colorado women who have been injured by abortion. The documents are either in the form of Affidavits or Declarations Under Penalty of Perjury, both of which are admissible in Federal Court with the same effect as sworn Affidavits.

These documents have been collected on behalf of Norma McCorvey, the former "Roe,, of Roe v. Wade, and Sandra Cano, the former "Doe,, of Doe v. Bolton, the lead Plaintiffs in the two cases that brought legalized abortion on-demand to America. Both of these women, were our clients, and they fully believe that the decisions brought in their names are grievous injustices and that abortion is in fact severely damaging to the mental, emotional, physical and spiritual health of women as well as killing a human being.

We have redacted the personally identifiable information to protect the confidentiality of the women. Testimonies similar to this of 180 women hurt by abortion were recently presented by us to the United States Supreme Court in the *Gonzalez v. Carhart* partial-birth abortion decision which upheld a federal ban on partial-birth abortion. The Supreme Court cited The Justice Foundation's brief, specifically to the pages where testimonies such as this were given and recognized that some women come to regret their abortions. "Whether to have an abortion requires a difficult and painful moral decision,, and is "fraught with emotional consequence,,, the Court said. The Court also noted that "severe depression and loss of esteem can follow,, an abortion.

Nothing was explained. I knew what I was doing but I had no idea it was such a major deal. I went to the clinic the day before the abortion where they inserted something to dialte my cervix. The next day the proceedure was performed. It was scary. The people there were quite callous. I figured they'd have to be to work in a place like that but there was no compassion anywhere. I felt like I was in one of those WWII movies where the Jews are processed through some line and then sent on to the concentration camp. I felt like a little child really wishing someone was there to hold my hand. I had to be brave but I was so afraid.

As far as I knew, I would have a little bleeding and cramping and feel fine in a few days. It was not that way at all. I had a lot of cramping, pain and bleeding and bled for several weeks following the abortion. I couldn't call my doctor because I was too ashamed to tell him what had happened. I tried taking an overdose of pain pills I had left over from some earliery surgery hoping I would die. I was sad when I didn't.

Sunday, I felt so guilty, as if everyone in church somehow knew I had had an abortion. I would cry through the years for no reason and would feel quite sad every year at the time the baby should have been born. I always knew at any given moment how old that child would have been had I allowed him to live. The year that child should have graduated from high school was especially hard. For years I didn't feel worthy to be a mother to my 2 incredible daughters.

#### 10. How has your abortion affected others in your life?

It caused a real conflict in our marriage for many years because I avoided sex as much as possible. It was horrible having to tell my high school/junior high daughters about it. I felt like I had really let them down - like I was a huge disappointment to them. I never told my parents for fear they couldn't deal with it

#### 11. Based upon your experience, what would you tell a woman considering abortion?

Please don't. You will always regret taking a life but you will never regret saving one, even if for a time it causes you great shame or humiliation. There is always good that will come out of saving your baby's life -it may take time for that to be recognized but any pain it initially causes you by not having an abortion will be worth it all someday - to so many people, not just yourself.

## 12. Based on your own experience, what would you tell a court that believes abortion should be legal?

I believe it is the highest form of abuse. Caregivers (abortion providers i.e. doctors) who have taken an oath to "first do no harm" do the greatest harm possible to women by facilitating the death of their own child. Many women are not there by choice, they are vulnerable, afraid and would give anything to have that caregiver look them in the eye, tell them the truth about abortion and tell them why it is the absolute wrong thing to do. It is also child abuse in it's worse form - a helpless child is murdered. It's insane to put child killers behind bars but allow doctors to kill pre-born children and become wealthy as a result.
