  DIRECTOR WITH SUBJECT MATTER EXPERTISE IN PHYSICAL PLANT
  SECURITY, SAFETY-RELATED TECHNOLOGY, THREAT ASSESSMENT, AND
  EARLY DETECTION AND RESPONSE TO DANGEROUS SITUATIONS IN SCHOOL
  SETTINGS, TO BE APPOINTED BY THE GOVERNOR;
  - (VIII) ONE MEMBER WHO REPRESENTS A RESEARCH PROGRAM THAT PROVIDES INFORMED ASSISTANCE TO GROUPS COMMITTED TO UNDERSTANDING AND PREVENTING VIOLENCE, PARTICULARLY ADOLESCENT VIOLENCE, TO BE APPOINTED BY THE GOVERNOR;
  - (IX) ONE MEMBER WHO IS A LICENSED PSYCHOLOGIST OR PSYCHIATRIST WITH EXPERIENCE TREATING ADOLESCENTS IN CRISIS, TO BE APPOINTED BY THE GOVERNOR;
  - (X) ONE MEMBER WHO IS AN ATTORNEY WHO IS LICENSED IN COLORADO AND WHO HAS EXPERIENCE WITH THE FEDERAL "FAMILY EDUCATIONAL RIGHTS AND PRIVACY ACT OF 1974", AS AMENDED, 20 U.S.C. SEC. 1232g, WITH SPECIAL EDUCATION REGULATIONS, AND WITH EDUCATION LAW, TO BE APPOINTED BY THE GOVERNOR; AND
- 23 (XI) ONE MEMBER WHO IS A LICENSED SPECIAL EDUCATION
  24 ADMINISTRATOR WHO HAS EXPERIENCE WORKING WITH STUDENTS WITH
  25 DISABILITIES AND WHO HAS KNOWLEDGE OF MENTAL HEALTH SUPPORTS IN
  26 PUBLIC SCHOOLS, TO BE APPOINTED BY THE GOVERNOR.".
