After consideration on the merits, the Committee recommends the following:

SB15-214 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

1 Amend printed bill, page 2, line 6, strike "**Mental Health**" and substitute
2 "**in Crisis**".

3 Page 2, line 7, strike "**mental health**" and substitute "**in crisis**".

4 Page 2, line 8, strike "**membership.**" and substitute "**membership -**
5 **repeal.**".

6 Page 2, line 9, strike "MENTAL HEALTH" and substitute "IN CRISIS".

7 Page 2, line 16, after "CRISIS;" add "AND".

8 Page 2, strike line 19 and substitute "STUDENTS.".

9 Page 3, strike lines 1 through 6 and substitute:

10 "(b) THE COMMITTEE MAY RECOMMEND LEGISLATIVE CHANGES
11 THAT SHALL BE TREATED AS LEGISLATION RECOMMENDED BY AN INTERIM
12 COMMITTEE FOR PURPOSES OF ANY INTRODUCTION DEADLINES OR BILL
13 LIMITATIONS IMPOSED BY THE JOINT RULES OF THE GENERAL ASSEMBLY.

14 (c) THE COMMITTEE SHALL MEET NO MORE THAN SIX TIMES EACH
15 LEGISLATIVE INTERIM, UNLESS ADDITIONAL MEETINGS ARE AUTHORIZED
16 BY THE EXECUTIVE COMMITTEE OF THE LEGISLATIVE COUNCIL, AND MAY
17 MEET AS NECESSARY THROUGHOUT THE".

- 1 Page 3, line 22, strike "GOVERNOR OR HIS OR HER DESIGNEE;" and
2 substitute "GOVERNOR;".
- 3 Page 3, strike lines 23 through 26 and substitute:
- 4 "(II) ONE MEMBER WHO IS A LICENSED SCHOOL EDUCATOR AND
5 EXPERIENCED IN WORKING WITH CHILDREN WITH DISABILITIES, AS DEFINED
6 IN SECTION 22-20-103 (5) (a), TO BE APPOINTED BY THE GOVERNOR;".
- 7 Page 4, line 3, strike "GOVERNOR OR HIS OR HER DESIGNEE;" and substitute
8 "GOVERNOR;".
- 9 Page 4, line 7, strike "GOVERNOR OR HIS OR HER DESIGNEE;" and substitute
10 "GOVERNOR;".
- 11 Page 4, line 9, strike "GOVERNOR OR HIS OR HER DESIGNEE;" and substitute
12 "GOVERNOR;".
- 13 Page 4, line 13, strike "GOVERNOR OR HIS OR HER DESIGNEE." and
14 substitute "GOVERNOR.".
- 15 Page 5, line 1, after "STAFF" insert "AND THE STAFF OF THE OFFICE OF
16 LEGISLATIVE LEGAL SERVICES".
- 17 Page 5, after line 2 insert:
- 18 "(6) THIS ARTICLE IS REPEALED, EFFECTIVE JULY 1, 2019.".
- 19 Page 1, strike lines 102 and 103, and substitute "SCHOOLS.".
