After consideration on the merits, the Committee recommends the following:

SB15-012 be amended as follows, and as so amended, be referred to the Committee on Finance with favorable recommendation:

1 Amend printed bill, page 2, line 9, strike "2015," and substitute "2016,".

2 Page 3, strike line 4 and substitute:

3 "(II) (A) EFFECTIVE JANUARY 1, 2017, AND UPON THE STATE
4 DEPARTMENT'S NOTIFICATION TO COUNTIES THAT THE RELEVANT HUMAN
5 SERVICES CASE MANAGEMENT SYSTEMS, INCLUDING THE AUTOMATED
6 CHILD SUPPORT ENFORCEMENT SYSTEM AND THE COLORADO BENEFITS
7 MANAGEMENT SYSTEM, ARE CAPABLE OF DIRECTLY AND EFFICIENTLY
8 MANAGING THE DISTRIBUTION PROCESS FOR THE CHILD SUPPORT
9 PASS-THROUGH, A COUNTY SHALL PAY FAMILIES".

10 Page 3, after line 18 insert:

11 "(B) THE GENERAL ASSEMBLY MAY ANNUALLY APPROPRIATE
12 MONEYS TO THE STATE DEPARTMENT IN A SEPARATE LINE ITEM TO
13 REIMBURSE THE COUNTIES FOR FIFTY PERCENT OF CHILD SUPPORT
14 COLLECTIONS AND THE FEDERAL GOVERNMENT FOR ITS SHARE OF CHILD
15 SUPPORT COLLECTIONS THAT ARE PASSED THROUGH TO TEMPORARY
16 ASSISTANCE FOR NEEDY FAMILIES (TANF) RECIPIENTS PURSUANT TO THIS
17 SUBPARAGRAPH (II). THE STATE DEPARTMENT SHALL ALLOCATE AND
18 DISTRIBUTE THE MONEYS TO THE COUNTIES. NOTWITHSTANDING THE
19 PROVISIONS OF THIS SUBPARAGRAPH (II) TO THE CONTRARY, IN ANY STATE
20 FISCAL YEAR IN WHICH THE GENERAL ASSEMBLY DOES NOT APPROPRIATE
21 AN AMOUNT OF MONEYS EQUAL TO A FULL FISCAL YEAR REIMBURSEMENT

1 TO COUNTIES PURSUANT TO THE PROVISIONS OF THIS SUB-SUBPARAGRAPH
2 (B), A COUNTY IS NOT REQUIRED TO IMPLEMENT THE CHILD SUPPORT PASS
3 THROUGH TO TEMPORARY ASSISTANCE FOR NEEDY FAMILIES (TANF)
4 RECIPIENTS."

5 Page 3, line 23, after "(3)," insert "AND EXCEPT AS PROVIDED IN SECTION
6 26-2-108 (1) (b) (II),".

7 Page 5, strike line 25 and substitute:

8 "(b) (I) EXCEPT AS PROVIDED IN SECTION 26-2-108 (1) (b) (II) (B),
9 EFFECTIVE JANUARY 1, 2017, A COUNTY SHALL PAY".
