After consideration on the merits, the Committee recommends the following:

HB15-1273 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

- 1 Amend page 4, line 1, strike "and" and strike "(IX)" and substitute "(IX),  
2 and (11)".
- 3 Page 4, line 5, strike "**definitions.**" and substitute "**definitions - repeal.**".
- 4 Page 5, line 14, after "EDUCATION" insert "OR INSTITUTE CHARTER  
5 SCHOOL BOARD FOR A CHARTER SCHOOL AUTHORIZED BY THE CHARTER  
6 SCHOOL INSTITUTE".
- 7 Page 7, line 4, after "ACTS" insert "OF SEXUAL VIOLENCE".
- 8 Page 7, line 5, strike "EVENT THAT" and substitute "EVENT".
- 9 Page 7, strike line 6 through 10 and substitute "ANY".
- 10 Page 8, after line 21 insert:  
11 "(11) (a) **Review of reporting requirements.** DURING THE 2020  
12 REGULAR LEGISLATIVE SESSION, THE EDUCATION AND JUDICIARY  
13 COMMITTEES OF THE HOUSE OF REPRESENTATIVES AND THE SENATE, OR  
14 ANY SUCCESSOR COMMITTEES, ARE ENCOURAGED TO FORMALLY REVIEW  
15 THE REPORTS RECEIVED FROM THE DIVISION OF CRIMINAL JUSTICE  
16 PURSUANT TO SECTION 24-33.5-503 (1) (bb), C.R.S. THE COMMITTEE  
17 MEMBERS ARE ENCOURAGED TO CONSIDER WHETHER TO:  
18 (I) CONTINUE TO REQUIRE LAW ENFORCEMENT OFFICERS AND  
19 DISTRICT ATTORNEYS TO SUBMIT DATA TO THE DIVISION OF CRIMINAL  
20 JUSTICE; OR

1 (II) INTRODUCE LEGISLATION TO REPEAL SUCH REPORTING  
2 REQUIREMENTS.

3 (b) THIS SUBSECTION (11) IS REPEALED, EFFECTIVE JULY 1, 2020."

4 Page 9, lines 13 and 14, strike "information relating to the preceding  
5 twelve months:" and substitute "information: ~~relating to the preceding~~  
6 ~~twelve months:~~".

7 Page 9, strike line 15 and substitute:

8 "(5) (a) ON OR BEFORE AUGUST 1, 2015,".

9 Page 9, line 16, strike "EVERY YEAR THEREAFTER,".

10 Page 9, line 19, strike "JUSTICE" and substitute "JUSTICE, IN THE FORMATS  
11 DEVELOPED BY THE DIVISION IN CONJUNCTION WITH LOCAL LAW  
12 ENFORCEMENT AGENCIES, THE INFORMATION REQUIRED PURSUANT TO  
13 PARAGRAPH (c) OF THIS SUBSECTION (5) THAT IS RELATED TO".

14 Page 9, line 20, strike "ARRESTS THAT OCCURRED" and substitute  
15 "TICKETS, SUMMONS, OR ARRESTS THAT OCCURRED DURING THE 2014-15  
16 ACADEMIC YEAR, EXCLUDING INCIDENTS THAT OCCURRED DURING THE  
17 SUMMER OF 2014,".

18 Page 9, line 22, strike "FOR EACH SUCH REPORT, THE".

19 Page 9, strike lines 23 and 24 and substitute:

20 "(b) ON OR BEFORE AUGUST 1, 2016, AND EVERY AUGUST 1  
21 THEREAFTER, EACH LAW ENFORCEMENT AGENCY THAT IS ACTING OR HAS  
22 ACTED IN ITS OFFICIAL CAPACITY ON SCHOOL GROUNDS, IN A SCHOOL  
23 VEHICLE, OR AT A SCHOOL ACTIVITY OR SANCTIONED EVENT SHALL  
24 REPORT TO THE DIVISION OF CRIMINAL JUSTICE, IN FORMATS DEVELOPED  
25 BY THE DIVISION IN CONJUNCTION WITH LOCAL LAW ENFORCEMENT  
26 AGENCIES, THE INFORMATION REQUIRED PURSUANT TO PARAGRAPH (c) OF  
27 THIS SUBSECTION (5) THAT IS RELATED TO ALL STUDENT TICKETS,  
28 SUMMONS, OR ARRESTS THAT OCCURRED FOR THE PREVIOUS ACADEMIC  
29 YEAR, INCLUDING INCIDENTS THAT OCCURRED DURING THE PREVIOUS  
30 SUMMER MONTHS, AT A PUBLIC ELEMENTARY SCHOOL, MIDDLE OR JUNIOR  
31 HIGH SCHOOL, OR HIGH SCHOOL; IN A SCHOOL VEHICLE; OR AT A SCHOOL  
32 ACTIVITY OR SANCTIONED EVENT.

1 (c) FOREACH REPORT REQUIRED PURSUANT TO PARAGRAPH (a) OR  
2 (b) OF THIS SUBSECTION (5), THE LAW ENFORCEMENT AGENCY SHALL  
3 REPORT:

4 (I) THE STUDENT'S FULL NAME;".

5 Renumber succeeding paragraphs as subparagraphs accordingly.

6 Page 10, line 8, strike "INVESTIGATED PER" and substitute "FOR WHICH A  
7 STUDENT IS ARRESTED, ISSUED A SUMMONS, OR ISSUED A TICKET".

8 Page 10, line 9, strike "INCIDENT".

9 Page 10, after line 15 insert:

10 "(d) A LAW ENFORCEMENT AGENCY MAY REPORT THE  
11 INFORMATION REQUIRED PURSUANT TO THIS SUBSECTION (5) ON A  
12 MONTHLY, QUARTERLY, OR ANNUAL BASIS. THE LAW ENFORCEMENT  
13 AGENCY SHALL INFORM THE DIVISION OF CRIMINAL JUSTICE OF THE  
14 REPORTING SCHEDULE IT WILL FOLLOW."

15 Page 11, line 9, strike "AN".

16 Page 11, line 10, strike "ARREST" and substitute "A TICKET, SUMMONS, OR  
17 OFFENSE".

18 Page 11, line 14, strike "BIRTH" and substitute "BIRTH, RACE, ETHNICITY,".

19 Page 11, lines 21 and 22, strike "EVERY TWO YEARS".

20 Page 11, line 24, after "OF" insert "TICKETS, SUMMONS, OR".

21 Page 11, line 27, after "THOSE" insert "TICKETS, SUMMONS, OR".

22 Page 12, after line 24 insert:

23 "(III) THE DIVISION SHALL ANNUALLY POST THE REPORT ON ITS  
24 WEB SITE."

25 Page 12, lines 26 and 27, strike "THE BEST AVAILABLE DATA" and  
26 substitute "EXISTING DATA SOURCES".

1 Strike pages 13 and 14 and substitute:  
2 "SECTION 6. In Colorado Revised Statutes, 2-2-1201, **repeal** (8).  
3 SECTION 7. In Session Laws of Colorado 2012, **repeal** section  
4 21 of chapter 188.  
5 SECTION 8. In Session Laws of Colorado 2012, **repeal** section  
6 46 of chapter 188.  
7 SECTION 9. **Safety clause.** The general assembly hereby finds,  
8 determines, and declares that this act is necessary for the immediate  
9 preservation of the public peace, health, and safety."
