**Bill Summary**

Currently, a hunter is required to wear fluorescent orange to hunt elk, deer, pronghorn, moose, or black bear. The bill adds the option to wear fluorescent pink.

1           **SECTION 1.** In Colorado Revised Statutes, 33-6-121, **amend** (1)  
2 introductory portion and (1) (a) as follows:

3           **33-6-121. Hunters to wear fluorescent pink or daylight**  
4 **fluorescent orange garments.** (1) Unless otherwise provided by  
5 commission rule, it is unlawful for any person to hunt or take elk, deer,  
6 pronghorn, moose, or black bear with any firearm unless ~~such~~ THE person  
7 is wearing FLUORESCENT PINK OR daylight fluorescent orange garments  
8 that meet the following requirements:

9           (a) Garments ~~shall be~~ ARE solid FLUORESCENT PINK OR daylight  
10 fluorescent orange colored material and ~~shall be~~ ARE of sufficient  
11 brightness to be seen conspicuously from a reasonable distance.

12           **SECTION 2. Act subject to petition - effective date.** This act  
13 takes effect at 12:01 a.m. on the day following the expiration of the  
14 ninety-day period after final adjournment of the general assembly (August  
15 10, 2016, if adjournment sine die is on May 11, 2016); except that, if a  
16 referendum petition is filed pursuant to section 1 (3) of article V of the  
17 state constitution against this act or an item, section, or part of this act  
18 within such period, then the act, item, section, or part will not take effect  
19 unless approved by the people at the general election to be held in  
20 November 2016 and, in such case, will take effect on the date of the  
21 official declaration of the vote thereon by the governor.
