in statute rather than in the constitution and stating that a
recall election shall be held as part of a general election if a
general election will be held between fifty and ninety days
after the time for filing a protest has passed and all protests
have been finally decided.

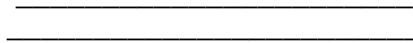
