A BILL FOR AN ACT

101 CONCERNING THE AUTHORITY OF THE PUBLIC EMPLOYEES'  
102 RETIREMENT ASSOCIATION TO DENY EMPLOYMENT TO  
103 INDIVIDUALS CONVICTED OF SPECIFIED OFFENSES.

Bill Summary

**Legislative Audit Committee.** Allows the public employees' retirement association (PERA) to deny employment to an individual who has been convicted of a felony or other specified offense if the individual, during his or her employment with PERA, would have access to PERA investment information, PERA assets, or other information relating to PERA members or beneficiaries.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1.** 24-5-101 (1) (b), Colorado Revised Statutes, is  
3 amended BY THE ADDITION OF A NEW SUBPARAGRAPH to read:

4           **24-5-101. Effect of criminal conviction on employment rights.**

5 (1) (b) This subsection (1) shall not apply to:

6           (VI) THE EMPLOYMENT OF PERSONS BY THE PUBLIC EMPLOYEES'  
7 RETIREMENT ASSOCIATION CREATED PURSUANT TO SECTION 24-51-201  
8 WHO, UPON THE COMMENCEMENT OF THAT EMPLOYMENT, WILL HAVE  
9 ACCESS TO ASSOCIATION INVESTMENT INFORMATION, ASSOCIATION  
10 ASSETS, OR FINANCIAL, DEMOGRAPHIC, OR OTHER INFORMATION RELATING  
11 TO ASSOCIATION MEMBERS OR BENEFICIARIES.

12           **SECTION 2. Safety clause.** The general assembly hereby finds,  
13 determines, and declares that this act is necessary for the immediate  
14 preservation of the public peace, health, and safety.
