THE COUNTY CLERK AND RECORDER OR DESIGNATED ELECTION OFFICIAL SHALL, WITHIN THREE DAYS AFTER THE DATE OF RECEIPT OF A MAIL BALLOT THAT DOES NOT CONTAIN A COPY OF IDENTIFICATION AS DEFINED IN SECTION 1-1-104 (19.5) (a) BUT IN NO EVENT LATER THAN TWO DAYS AFTER ELECTION DAY, SEND TO THE ELIGIBLE ELECTOR AT THE ADDRESS INDICATED ON THE REGISTRATION RECORDS A LETTER EXPLAINING THE REQUIREMENTS PERTAINING TO VERIFICATION OF IDENTIFICATION. IF THE COUNTY CLERK AND RECORDER OR DESIGNATED ELECTION OFFICIAL RECEIVES FROM THE ELECTOR A COPY OF IDENTIFICATION IN COMPLIANCE WITH PARAGRAPH (b) OF THIS SUBSECTION (3) WITHIN EIGHT DAYS AFTER ELECTION DAY, AND THE MAIL BALLOT IS OTHERWISE VALID, THE MAIL BALLOT MUST BE COUNTED."
