Economic Opportunity Poverty Reduction Task Force

On behalf of the Northern Colorado Economic Development Corporation, we support HB 1064 in that it is asking for the formation of a poverty task force. The widening gap of poverty in Northern Colorado has been an issue our community has been studying for quite some time. We can be very proud of the community coming together for months in an impressive grass roots effort to find the solution. NCEDC helped drive the poverty study completed by our regional economist, Dr. Martin Shields.

In addition, I believe the increasing challenges facing, not only Northern Colorado but the state of Colorado due to the current economic climate, is a serious and urgent economic development issue. For example, the increase in companies laying workers off has a direct impact on the ability of those unemployed workers to keep their homes and provide for their family. There is an increase in the burden to non-profit organizations such as the food banks, homeless shelters, as well as the increase to public education as school lunch program costs go up. As more people find the need to ask for assistance, it places a burden on tax payers, businesses, governments, community, etc.

It will take economic development organizations, like ourselves, business and industry partners, chambers of commerce, workforce centers, state and local governments, elected officials and many others who influence our state's economy – all of us must weigh in on the solution to this subject. I am hopeful the minds in the room could create immediate outcomes that our state's citizens and companies so desperately need.

Our organization is doing our part as we focus our efforts on influencing a strong business climate, helping our existing primary employers to thrive and attract suitable companies. We are poised and ready to be collaborative where we can, not just for Northern Colorado, but for our entire state. In other words, our attitude of partnering and working together is paramount with us as we tackle very large challenges that face us all economically.
