SUBJECT: Fiscal Assessment of Proposed Amendment **HB1086_L.001**.

This memorandum is an assessment of the fiscal impact of the attached proposed amendment to **HB09-1086**. This fiscal assessment is for the impact of the bill with inclusion of this amendment <u>only</u>. Any other added amendment could influence the fiscal impact.

Summary of Proposed Amendment

Amendment L.001 changes the bill to clarify that:

- the test of continued competency for mental health professionals be a self administered test;
- either the director of the Division of Registrations or the appropriate mental health board may determine qualifications for license renewals;
- periodic demonstration of knowledge and skills be supported by documentation of continued competency activities; and
- mental health professionals are not required to retake any test connected to an initial license application.

With regard to rules promulgated for addiction counselors, the director of the division must consult with the Alcohol and Drug Abuse Division in the Colorado Department of Human Services, in addition to other stakeholders.

Fiscal Impact of Amendment

The amendment makes clarifying changes to the bill; however, these changes do not change the fiscal impact of the introduced bill. For information on the revenue and expenditures of HB09-1086, please refer to the fiscal note dated January 26, 2009.

Bill's Revised Fiscal Impact with Amendment

If L.001 is adopted, there will be no change to the fiscal impact of HB09-1086. Revenue from fees to the Division of Registrations Cash Fund remain estimated at \$164,472 in FY 2009-10 and \$117,480 in FY 2010-11.

Costs of the bill remain \$134,123 and 1.2 FTE to the Department of Regulatory Agencies in FY 2009-10 and \$79,277 and 1.0 FTE to the department in FY 2010-11.
