Bill Summary

Joint Select Committee on Job Creation and Economic Growth. Requires the division of employment and training (division) in the department of labor and employment, in cooperation with the department of health care policy and financing, the division of insurance

in the department of regulatory agencies, and representatives of private health plan and underwriting trade associations, to develop an informational resource detailing public and private sector health care coverage options and programs available to persons who become unemployed and are seeking unemployment insurance benefits. Requires the division to distribute the information in written form to unemployment insurance benefits applicants and to post the information on its web site. Allows the division to partner with a nonprofit organization to perform functions related to developing the informational resource and providing counseling to unemployed individuals seeking health care coverage options and programs.

Be it enacted by the General Assembly of the State of Colorado:

2 SECTION 1. 8-72-103, Colorado Revised Statutes, is amended 3 to read:

8-72-103. Publications. (1) The director of the division shall determine what information should be made public in order to carry out the provisions of articles 70 to 82 of this title. Materials of the division circulated in quantity outside the executive branch shall be issued in accordance with the provisions of section 24-1-136, C.R.S.

- (2) (a) THE DIVISION, IN COOPERATION WITH THE DEPARTMENT OF HEALTH CARE POLICY AND FINANCING, THE DIVISION OF INSURANCE IN THE DEPARTMENT OF REGULATORY AGENCIES, AND REPRESENTATIVES OF PRIVATE HEALTH PLAN AND UNDERWRITING TRADE ASSOCIATIONS, SHALL DEVELOP AN INFORMATIONAL RESOURCE FOR AN INDIVIDUAL CLAIMING BENEFITS UNDER THE "COLORADO EMPLOYMENT SECURITY ACT", REFERRED TO IN THIS SECTION AS THE "ACT", TO ACCESS INFORMATION ABOUT AVAILABLE PRIVATE AND PUBLIC SECTOR HEALTH CARE COVERAGE OPTIONS AND PROGRAMS FOR WHICH THE INDIVIDUAL MAY BE ELIGIBLE. THE INFORMATION SHALL INCLUDE AT LEAST THE FOLLOWING:
- (I) A DESCRIPTION OF THE PUBLIC HEALTH CARE COVERAGE

- 1 OPTIONS AND PROGRAMS AVAILABLE, INCLUDING THE ELIGIBILITY 2 CRITERIA, PERTINENT CONTACT INFORMATION FOR THE GOVERNMENT 3 ENTITIES THAT ADMINISTER EACH PROGRAM, INCLUDING TELEPHONE 4 NUMBERS, PHYSICAL LOCATION, MAILING ADDRESS, ELECTRONIC MAIL 5 ADDRESS, AND WEB SITE ADDRESS, AND THE METHOD BY WHICH AN 6 INDIVIDUAL MAY APPLY TO PARTICIPATE; AND 7 (II) A DESCRIPTION OF PRIVATE SECTOR HEALTH CARE COVERAGE 8 OPTIONS AND PROGRAMS AVAILABLE AND PERTINENT CONTACT 9 INFORMATION FOR THE PRIVATE ENTITIES THAT OFFER THE DESCRIBED 10 HEALTH CARE COVERAGE, INCLUDING TELEPHONE NUMBERS, PHYSICAL 11 LOCATION, MAILING ADDRESS, ELECTRONIC MAIL ADDRESS, AND WEB SITE 12 ADDRESS. 13 (b) THE DIVISION SHALL PROVIDE COPIES OF WRITTEN MATERIALS 14 CONTAINING THE INFORMATION SPECIFIED IN PARAGRAPH (a) OF THIS 15 SUBSECTION (2) TO ANY INDIVIDUAL WHO MAKES A CLAIM FOR BENEFITS 16 UNDER THE ACT AND SHALL POST THE INFORMATION ON ITS WEB SITE. THE 17 DIVISION, IN COOPERATION WITH THE ENTITIES SPECIFIED IN PARAGRAPH 18 (a) OF THIS SUBSECTION (2), SHALL ENSURE THAT THE INFORMATION ON 19 PRIVATE AND PUBLIC SECTOR HEALTH CARE COVERAGE OPTIONS AND 20 PROGRAMS IS UPDATED ON A REGULAR BASIS SO AS TO PROVIDE 21 CLAIMANTS WITH THE MOST ACCURATE INFORMATION POSSIBLE. 22 (c) THE DIVISION MAY OBTAIN ASSISTANCE FROM A NONPROFIT
 - (c) THE DIVISION MAY OBTAIN ASSISTANCE FROM A NONPROFIT ORGANIZATION FOR PURPOSES OF DEVELOPING AND UPDATING THE INFORMATION SPECIFIED IN THIS SUBSECTION (2), AGGREGATING PERTINENT DATA, AND PROVIDING COUNSELING SERVICES TO INTERESTED INDIVIDUALS THROUGH PERSONAL, TELEPHONIC, OR WEB-BASED SERVICES.
