SHORT TITLE: "Enterprise Zone Recommendations To GA"

A BILL FOR AN ACT 101 CONCERNING DIRECTION TO THE ECONOMIC DEVELOPMENT 102 COMMISSION TO DEVELOP RECOMMENDATIONS FOR THE 103 GENERAL ASSEMBLY REGARDING ENTERPRISE ZONES.

Bill Summary

(Note: This summary applies to this bill as introduced and does not necessarily reflect any amendments that may be subsequently adopted.)

Joint Select Committee on Job Creation and Economic Growth. Directs the economic development commission (commission), with assistance from the Colorado office of economic development, to develop recommended criteria for the potential creation of a statewide enterprise zone, for the expansion of the boundaries of one or more existing enterprise zones, or for the modification of existing enterprise

zone credits. Specifies the aspects of enterprise zones that the commission shall consider.

Requires the commission to submit a report to the general assembly with its recommendations regarding enterprise zones, including recommendations regarding the creation of a statewide enterprise zone.

1 Be it enacted by the General Assembly of the State of Colorado: 2 SECTION 1. Part 1 of article 46 of title 24, Colorado Revised 3 Statutes, is amended BY THE ADDITION OF A NEW SECTION to 4 read: 5 24-46-104.5. Statewide enterprise zone - existing enterprise 6 zones - recommendations to the general assembly - repeal. (1) THE 7 COMMISSION, WITH INPUT FROM THE COLORADO OFFICE OF ECONOMIC 8 DEVELOPMENT, SHALL DEVELOP RECOMMENDED CRITERIA FOR THE 9 POTENTIAL CREATION OF A STATEWIDE ENTERPRISE ZONE, THE EXPANSION 10 OF THE BOUNDARIES OF ONE OR MORE EXISTING ENTERPRISE ZONES, OR 11 THE MODIFICATION OF EXISTING ENTERPRISE ZONE CREDITS.
