# Drinking Water Revolving Fund Categories

Category 1 - Acute Health Hazard. The WQCD has identified continuous violation of an acute maximum contaminant level (MCL) or a surface water treatment rule (SWTR) treatment technique requirement. *(Long term or frequent boil orders/bottled water advisories were included in this definition).*

Category 2 - Chronic (long term) Health Hazard. The WQCD has identified a continuous violation of an MCL or an SWTR treatment technique requirement for a chronic contaminant.

Category 3 - Potential Acute Health Hazard. The PWS has periodically exceeded an acute MCL, has levels greater than 50 percent of an acute MCL on a regular basis, or has short term problems meeting an SWTR treatment technique requirement that can be controlled temporarily by operational means.

Category 4 - Potential Chronic Health Hazard. The PWS has periodically exceeded a chronic MCL, has levels greater than 50 percent of a chronic MCL on a regular basis, or has short term problems meeting other treatment technique requirements.

Category 5 - Other Future Needs. The PWS is beyond the useful/design life and is in need of equipment replacement, rehabilitation or repair, in order to maintain compliance or further the public health protection goals of the SDWA.

Category 6 - Projects that requested to be considered for funding only under ARRA that were not already on the Eligibility List.

Within each category projects are prioritized based on points assigned for:

- Projects serving a small community
- Entities that have a greater financial based
  - Ability to pay (total annual sewer cost per single family equivalent as a % of median household income)
  - Local burden (total project cost per equivalent residential tap)
- Consolidation
- Water Conservation
- Implementation of Source Water Protection measures
- Beneficial Use of Sludge
- Health Risk

# Water Pollution Control Revolving Fund Categories

Category 1 includes those projects that improve, or benefit public health or that will remediate a public health hazard

Category 2 includes those projects that enable an entity to achieve permit compliance

Category 3 includes those projects that contribute to the prevention of a public health hazard; enable an entity to maintain permit compliance; or enables an entity to address a possible future effluent limit or emerging issue.

Category 4 includes those projects that implement a watershed/nonpoint source management plan

Category 5 includes those project that implement a source water protection plan.

Category 6 - Projects that requested to be considered for funding only under ARRA that were not already on the Eligibility List.

Within each category projects are prioritized based on points assigned for:

- Projects serving a small community
- Entities that have a greater financial based
  - Ability to pay
  - Local burden
- Projects that address an enforcement action and/or compliance schedule
- Projects that address the discharge of pollutant(s) to a segment impaired for the relevant pollutant(s)
- Projects that implement the “Green Infrastructure/Sustainable Measures”

**April 13, 2009:** Administrative Action hearing to review IUP Addendums and allow for public comment

**May 11, 2009:** Administrative Action hearing to approve category rankings list

**May 29, 2009:** Administrative Action Hearing to adopt IUP Addendum and fundable list

### **WQCC Establishes deadlines required to determine “ready-to-proceed”**

**February 17, 2009:** ARRA Signed into law

**March 23, 2009:** Submit an approvable Preliminary Engineering Report (PER)

**April 27, 2009:**

- Submit a stimulus loan application and a complete/approvable Site Application (WPCRF)
- Submit a stimulus loan application and Technical, Managerial and Financial Capacity Assessment (DWRF)

**May 31, 2009:**

- Submit a complete/approvable Process Design Report or Engineering Report (WPCRF)
- Submit a complete/approvable Engineering Report (DWRF)

**June 30, 2009:** Submit complete/approvable Plans and Specifications and Environmental Assessment Report, or proof that the project qualifies as a Categorical Exclusion from the environmental process.

**July 31, 2009:** Fully respond to any WQCD questions and comments.

**September 30, 2009:** Complete bidding process, issue Notice to Proceed, and begin construction.
