12 THE ORIGIN AND VERSION NUMBER OF ANY SOFTWARE USED TO OTHERWISE
13 PRODUCE BALLOTS AND THE NUMBER OF SUCH BALLOTS;

14 (D) FOR EACH POLITICAL PARTY, THE NUMBERS OF BALLOTS
15 MAILED, DELIVERED FROM GROUP FACILITIES PURSUANT TO SECTION
16 1-8-112, DELIVERED DIRECTLY TO ELECTORS, OR OTHERWISE MADE
17 AVAILABLE TO ELECTORS; AND

18 (E) FOR EACH POLITICAL PARTY, THE NUMBERS OF BALLOTS
19 RETURNED BY MAIL, RETURNED TO A DROP-OFF LOCATION, EXCHANGED
20 FOR A REPLACEMENT BALLOT, SURRENDERED BY AN ELECTOR WHO CASTS
21 A BALLOT AT A SERVICE CENTER, RETURNED TO THE DESIGNATED
22 ELECTION OFFICIAL AS UNDELIVERABLE, OR OTHERWISE ADMINISTERED BY
23 THE DESIGNATED ELECTION OFFICIAL;

24 (V) FOR EACH ELIGIBLE ELECTOR WHOSE MAIL-IN BALLOT WAS
25 RECEIVED BUT NOT COUNTED, A DESCRIPTION AND EXPLANATION OF THE
26 ACTION TAKEN BY THE COUNTY FOR SIMILARLY SITUATED ELECTORS,
27 SUMMARIZED BY GROUP TO PRESERVE THE ANONYMITY OF SUCH
28 ELECTORS;

29 (VI) FOR EACH MAIL-IN BALLOT OR PORTION THEREOF COUNTED
30 IN ERROR, A DESCRIPTION AND EXPLANATION OF THE ACTION TAKEN BY
31 THE COUNTY FOR SIMILARLY SITUATED BALLOTS, SUMMARIZED BY GROUP
32 TO PRESERVE THE ANONYMITY OF THE ASSOCIATED ELECTORS; AND

33 (VII) FOR ANY OTHER PROBLEMS REPORTED OR SUGGESTIONS
34 MADE IN THE COURSE OF A PRIMARY ELECTION CONDUCTED IN 2010 AS A
