Dear Annette,

You need to send Richard; Joseph's Dr. information. Please forward that information on to him.

Secondly, I have been informed by your attorney that you are refusing to sign the agreement that I drew up. This is unacceptable!

★ Either you sign my agreement for parenting time issues and all issues that I am recommending, or I will be forced to go to the judge and recommend custody of Joseph to Richard. Linda tells me that you are unhappy about all my fees, that you told her that in the beginning of our work together I said I would only need the initial retainer of \$1500.00 that I work quickly and you would probably get money back. (That is correct, I said this, however I did not expect your case to take so long and I am demanding another retainer from you. If you would cooperate and sign my agreement, that would save you money. You have told Linda that you have no more money and no one else to borrow from, well you need to find it or I will be forced to take you to court for my fees. I will also charge you for the time I spend preparing for and taking you to court plus court costs. I have tried to be understanding about your situation but I need to be paid.

I will expect this next retainer of \$2500.00 by March 15th or I go to the judge and have you held in contempt, bill you for my time, and court costs. Then in my final report I recommend custody to Richard. ~~★ extortion!~~

I will be awaiting your reply as to when you will sign my agreement and that you will send in the new retainer.

I had a phone call from Linda Cohn stating that you feel I am overcharging you and that I am not sending itemized statements. Linda also informed me that you stated that I said I would only need the first retainer of \$1500.00 and that you would be getting funds back from me because I would get the evaluation done quickly. I never said this! None of my cases are done "fast" and no one gets by on one retainer. The normal time for an advocate to be on a case is at least a year, so where did you get the idea that this would be done in one retainer? Certainly not from me.

Since you chose to ignore my request for my retainer of \$2500.00 that was due back on March 15th, I have no choice but to go now to the judge. I will be filing a motion to get myself paid and I will be charging you for the time I spend filing the motion, the time I drive to and spend in court and court costs. You are not going to like my recommendations to the court regarding custody of your son due to your lack of payment of retainers. I have warned you repeatedly, and you have not paid nor responded to my requests for payment.

In closing I'll just say, see you in court.
