After consideration on the merits, the Committee recommends the following:

SB09-295 be amended as follows:

- 1 Amend printed bill, page 3, strike lines 2 through 14.
- 2 Strike pages 4 and 5.
- 3 Page 6, strike lines 1 through 6.
- 4 Renumber succeeding sections accordingly.
- 5 Page 6, line 16, strike "23-41-104.6 (4) and (5) (c) (I)," and substitute
- 6 "23-41-104.6 (4),";
- 7 line 17, strike "are" and substitute "is".
- 8 Page 7, strike lines 21 through 27.
- 9 Strike page 8.
- 10 Page 9, strike lines 1 through 9 and substitute the following:
- 11 **"SECTION 3. 23-5-129 , Colorado Revised Statutes, is amended**
- 12 **BY THE ADDITION OF A NEW SUBSECTION to read:**
- 13 **23-5-129. Governing boards - performance contract -**
- 14 **authorization - operations. (11) THE DEPARTMENT OF HIGHER**
- 15 **EDUCATION, IN CONSULTATION WITH THE GOVERNING BOARDS OF THE**
- 16 **STATE INSTITUTIONS OF HIGHER EDUCATION, SHALL DEVELOP A MEASURE**



1 OR MEASURES THAT, IN THE CONTEXT OF DELEGATING TUITION-SETTING
2 AND FINANCIAL AID DISCRETION TO THE GOVERNING BOARDS, ASSURES
3 RESIDENT STUDENTS ADEQUATE ACCESS TO AND THE AFFORDABILITY OF
4 COSTS OF ATTENDANCE AT STATE PUBLIC INSTITUTIONS OF HIGHER
5 EDUCATION, AND BY MARCH 1, 2010, THE COMMISSION ON HIGHER
6 EDUCATION SHALL ADOPT SUCH MEASURES, ANTICIPATING THAT
7 TUITION-SETTING AND FINANCIAL AID DISCRETION WILL DEVOLVE TO THE
8 GOVERNING BOARDS FOR THE ACADEMIC YEAR 2011-12 AND THEREAFTER.
9 THE COMMISSION SHALL ADJUST ITS FINANCIAL AID POLICIES FOR 2009-10
10 AND 2010-11 IN ORDER TO GIVE THE GOVERNING BOARDS APPROPRIATE
11 ADDITIONAL FLEXIBILITY WITHIN THE PROVISIONS OF CURRENT LAW."

12 Renumber succeeding sections accordingly.
