After consideration on the merits, the Committee recommends the following:

HB09-1350 be amended as follows:

1 Amend printed bill, page 3, strike line 3 and substitute the following:

2 "BE CITED AS THE "ENERGY EFFICIENCY AND RENEWABLES JOBS ACT".

3 Page 8, line 23, strike "AND".

4 Page 9, strike line 1 and substitute the following:

5 "PROPERTY; AND

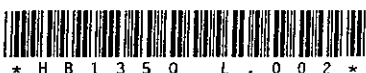
6 (c) MEETS ANY STANDARD OF CREDIT-WORTHINESS THAT THE
7 DISTRICT MAY ESTABLISH."

8 Page 18, line 17, strike "GUIDELINES AND PROCEDURES" and substitute
9 "STANDARDS, GUIDELINES, AND PROCEDURES, INCLUDING BUT NOT
10 LIMITED TO STANDARDS OF CREDIT-WORTHINESS FOR QUALIFICATION OF
11 PROGRAM APPLICANTS,";

12 after line 19, insert the following:

13 "(d) ENCOURAGE ANY QUALIFIED APPLICANT TO OBTAIN AN
14 ONLINE OR ON-SITE HOME ENERGY AUDIT IN ORDER TO ENSURE THAT THE
15 EFFICIENT USE OF NEW ENERGY IMPROVEMENT FUNDING PURSUANT TO
16 THIS ARTICLE;

17 (e) INFORM PROSPECTIVE PROGRAM APPLICANTS AND QUALIFIED



1 APPLICANTS OF PRIVATE FINANCING OPTIONS NOT PROVIDED BY THE
2 DISTRICT, INCLUDING BUT NOT LIMITED TO HOME EQUITY LOANS AND
3 HOME EQUITY LINES OF CREDIT, THAT MAY, WITH RESPECT TO A
4 PARTICULAR APPLICANT, REPRESENT VIABLE ALTERNATIVES FOR
5 FINANCING NEW ENERGY IMPROVEMENTS;".

6 Reletter succeeding paragraphs accordingly.

7 Page 24, line 21, after "RESOLUTION", insert "AND ASSESSMENT ROLL".

8 Page 26, line 1, strike "(a)";

9 strike lines 10 through 27.

10 Strike pages 27 and 28.

11 Page 29, strike line 1.

12 Page 33, after line 25, insert the following:

13 "SECTION 2. 31-25-1102 (2), Colorado Revised Statutes, is
14 amended to read:

15 **31-25-1102. Definitions.** As used in this part 11, unless the
16 context otherwise requires:

17 (2) "Taxing authority" means THE COLORADO NEW ENERGY
18 IMPROVEMENT DISTRICT CREATED IN SECTION 32-20-104 (1), C.R.S., AND
19 any municipal corporation or taxing district organized under the
20 constitution and laws of the state of Colorado with power to make local
21 improvements therein and pay for the same by means of special
22 assessments based upon benefits accruing to property within the
23 municipality or taxing district by reason of such local improvement."

24 Renumber succeeding section accordingly.

25 Page 1, line 101, strike ""NEW ENERGY IMPROVEMENTS AND JOBS";

26 line 102, strike "CREATION ACT" and substitute ""ENERGY EFFICIENCY
27 AND RENEWABLES JOBS ACT".
