- (e) The appropriation to the department of natural resources, water resources division, for operating expenses, is decreased by one hundred thirty-eight thousand nine hundred forty-one dollars (\$138,941). Said sum shall be from the General Fund.
- 10 (f) The appropriation to the department of natural resources, water 11 resources division, for operating expenses, is increased by one hundred 12 thirty-eight thousand nine hundred forty-one dollars (\$138,941) cash funds. Of said sum, one hundred four thousand two hundred six dollars 13 (\$104,206) shall be from the division of water resources ground water 14 15 management cash fund established pursuant to section 37-80-111.5 (1) 16 (d), Colorado Revised Statutes, and thirty-four thousand seven hundred thirty-five dollars (\$34,735) shall be from the well inspection cash fund 17 established pursuant to section 37-80-111.5 (1) (d), Colorado Revised 18 19 Statutes.
- 20 (g) The appropriation to the department of natural resources, water resources division, for indirect cost assessment, is increased by 22 sixty-one thousand three hundred seventy-four dollars (\$61,374) cash 23 funds. Of said sum, forty-six thousand thirty dollars (\$46,030) shall be from the division of water resources ground water management cash fund established pursuant to section 37-80-111.5 (1) (d), Colorado Revised Statutes, and fifteen thousand three hundred forty-four dollars (\$15,344) shall be from the well inspection cash fund established pursuant to section 37-80-111.5 (1) (d), Colorado Revised Statutes.".
