HB09-1328 be amended as follows:

- 1 Amend printed bill, page 2, strike lines 6 and 7;
- 2 line 8, strike "(2.7)" and substitute "(2.5)";
- 3 line 22, strike "EACH GOVERNMENTAL BODY SHALL" and substitute
- 4 "WHEN A";
- 5 line 23, strike "REQUIRE THAT EVERY";
- 6 line 25, strike "CONTAIN" and substitute, "IS TO BE AWARDED TO A BIDDER,
- 7 A GOVERNMENTAL BODY SHALL AWARD THE CONTRACT TO A BIDDER
- 8 WHOSE BID CONTAINS";
- 9 line 26, strike "OR FOUNDRY";
- 10 strike line 27 and substitute the following:
- 11 "PERFORMANCE OF THE CONTRACT, ONLY STEEL".
- 12 Page 3, line 1, strike "FOUNDRY";
- 13 line 2, strike "CONTRACT OR ANY OF THE" and substitute "CONTRACT. THE
- 14 PREFERENCE IN THIS SECTION SHALL APPLY";
- 15 line 3, strike "SUBCONTRACTS";



- 1 line 4, strike "OR FOUNDRY";
- 2 line 7, strike "OR FOUNDRY";
- 3 line 10, strike "OR FOUNDRY";
- 4 line 13, strike "OR FOUNDRY";
- 5 line 18, strike "OR FOUNDRY";
- 6 line 26, strike "OR FOUNDRY".
- 7 Page 4, line 8, strike "SUIT FILED" and substitute "USE OF THE
- 8 PRELITIGATION PROCEDURES CONTAINED IN PART 1 OF ARTICLE 109 OF
- 9 THIS TITLE.";
- 10 strike lines 9 and 10;
- 11 line 12, strike "HEAD" and substitute "EXECUTIVE DIRECTOR";
- 12 line 13, strike "OR FOUNDRY";
- 13 after line 17, insert the following:
- 14 "SECTION 3. 24-101-105, Colorado Revised Statutes, is
- 15 amended BY THE ADDITION OF A NEW SUBSECTION to read:
- 16 **24-101-105. Application of this code.** (5) NOTWITHSTANDING
- 17 THE PROVISIONS OF SUBSECTION (1) OF THIS SECTION, SECTION
- 18 24-103-207.7 SHALL APPLY TO THE PROCUREMENT OF BRIDGE AND
- 19 HIGHWAY CONSTRUCTION."
- 20 Renumber succeeding section accordingly.
