1 "(5) THE OLD HIRE PENSION FUNDS ESTABLISHED BY THIS ARTICLE 2 SHALL BE HELD IN TRUST FOR THE BENEFIT OF OLD HIRE MEMBERS AND 3 OTHER PERSONS ENTITLED TO BENEFITS.
