HB09-1175 be amended as follows:

- 1 Amend printed bill, page 7, line 27, strike "AN" and substitute "A
- 2 COMPLETED".
- 3 Page 8, line 11, after "REGISTER", insert "BY ENDORSEMENT".
- 4 Page 10, line 2, strike "ARTICLE." and substitute "ARTICLE OR SECTION
- 5 24-34-102 (8), C.R.S.";
- 6 line 3, strike "(c)" and substitute "(5)";
- 7 line 5, strike "(5)" and substitute "(6)";
- 8 line 8, after "C.R.S.", add "FEES MAY BE SPENT FOR EXPENSES OF THE
- 9 DIVISION IN STAFFING THE TASK FORCE.";
- 10 line 16, after the period, add "A NATUROPATHIC DOCTOR SHALL OBSERVE
- 11 AND BE SUBJECT TO ALL APPLICABLE LAWS WITH REGARD TO THE CONTROL
- 12 OF CONTAGIOUS AND INFECTIOUS DISEASES, THE REPORTING OF BIRTHS
- 13 AND DEATHS, AND ANY OTHER MATTERS PERTAINING TO THE PUBLIC
- 14 HEALTH.".
- 15 Page 13, line 16, strike "SHALL" and substitute "MAY";
- 16 line 17, strike "REGISTRATION" and substitute "REGISTRATION, PLACE A
- 17 REGISTRANT ON PROBATION,".



1 Page 14, strike lines 9 through 12 and substitute the following:

2 "HAVING SIMILAR EFFECTS."

3 Page 16, line 11, strike "OR";

4 strike lines 12 through 19 and substitute the following:

5 (p) HAS FAILED TO MEET GENERALLY ACCEPTED STANDARDS OF  
6 NATUROPATHIC PRACTICE;

7 (q) HAS FAILED TO REFER A PATIENT TO THE APPROPRIATE  
8 LICENSED HEALTH CARE PRACTITIONER WHEN THE SERVICES REQUIRED BY  
9 THE PATIENT ARE BEYOND THE LEVEL OF COMPETENCE OF THE  
10 NATUROPATHIC DOCTOR OR BEYOND THE SCOPE OF THIS ARTICLE; OR

11 (r) HAS PERFORMED A PROCEDURE IN THE COURSE OF PATIENT  
12 CARE THAT IS BEYOND THE NATUROPATHIC DOCTOR'S TRAINING OR  
13 COMPETENCE OR BEYOND THE SCOPE OF PRACTICE OF THIS ARTICLE."

14 Page 22, strike lines 17 through 27 and substitute the following:

15 "(12) IF IT APPEARS TO THE DIRECTOR, BASED UPON CREDIBLE  
16 EVIDENCE PRESENTED TO THE DIRECTOR, THAT A PERSON HAS ENGAGED OR  
17 IS ABOUT TO ENGAGE IN AN UNREGISTERED ACT OR PRACTICE; AN ACT OR  
18 PRACTICE CONSTITUTING A VIOLATION OF THIS ARTICLE; A RULE  
19 PROMULGATED PURSUANT TO THE ARTICLE; AN ORDER ISSUED PURSUANT  
20 TO THIS ARTICLE; OR AN ACT OR PRACTICE CONSTITUTING GROUNDS FOR  
21 ADMINISTRATIVE SANCTION PURSUANT TO THIS ARTICLE, THE DIRECTOR  
22 MAY ENTER INTO A STIPULATION WITH THE PERSON."
