**A BILL FOR AN ACT**

101 **CONCERNING EXPEDITED PROCESSES FOR REENROLLMENT IN**  
102 **PUBLICLY FUNDED MEDICAL PROGRAMS.**

**Bill Summary**

Directs the department of health care policy and financing to establish a process for reenrollment in medicaid and the children's basic health plan both over the telephone and through the internet.

1           **SECTION 1.** 25.5-4-205 (3), Colorado Revised Statutes, is  
2 amended BY THE ADDITION OF A NEW PARAGRAPH to read:

3           **25.5-4-205. Application - verification of eligibility -**  
4 **demonstration project - rules - repeal.** (3) (e) (I) IN COLLABORATION  
5 WITH AND TO AUGMENT THE STATE DEPARTMENT'S EFFORTS TO SIMPLIFY  
6 ELIGIBILITY DETERMINATIONS FOR BENEFITS UNDER THE STATE MEDICAL  
7 ASSISTANCE PROGRAM AND THE CHILDREN'S BASIC HEALTH PLAN,  
8 THE STATE DEPARTMENT SHALL ESTABLISH A PROCESS SO THAT A  
9 RECIPIENT, ENROLLEE, OR THE PARENT OR GUARDIAN OF A RECIPIENT OR  
10 ENROLLEE MAY APPLY FOR REENROLLMENT EITHER OVER THE TELEPHONE  
11 OR THROUGH THE INTERNET.

12           (II) (A) SUBJECT TO RECEIPT OF FEDERAL AUTHORIZATION AND  
13 SPENDING AUTHORITY, THE STATE DEPARTMENT MAY IMPLEMENT A PILOT  
14 PROGRAM THAT ALLOWS A LIMITED NUMBER OF RECIPIENTS OR ENROLLEES  
15 TO APPLY FOR REENROLLMENT EITHER OVER THE TELEPHONE OR THROUGH  
16 THE INTERNET DURING A TRANSITION TO A PROCESS THAT WILL SERVE  
17 RECIPIENTS AND ENROLLEES STATEWIDE. THE PILOT PROGRAM SHALL NOT  
18 SERVE AS A REPLACEMENT FOR A STATEWIDE PROCESS.

19           (B) NOTWITHSTANDING ANY OTHER PROVISION IN THIS  
20 PARAGRAPH (e), THE STATE DEPARTMENT SHALL NOT IMPLEMENT THIS  
21 PARAGRAPH (e) UNTIL IT CAN VERIFY THE ELIGIBILITY OF A RECIPIENT OR  
22 ENROLLEE OVER THE TELEPHONE OR THROUGH THE INTERNET AS  
23 AUTHORIZED BY RULES OF THE STATE DEPARTMENT AND FEDERAL LAW.

24           (C) NOTWITHSTANDING ANY OTHER PROVISION IN THIS  
25 PARAGRAPH (e), THE STATE DEPARTMENT SHALL NOT IMPLEMENT OR  
26 ADMINISTER ANY PORTION OF THIS PARAGRAPH (e) UNTIL SPENDING  
27 AUTHORITY HAS BEEN RECEIVED IN THE GENERAL APPROPRIATION ACT OR

1 ANY SUPPLEMENTAL APPROPRIATION AND SHALL ONLY IMPLEMENT AND  
2 ADMINISTER THIS PARAGRAPH (e) TO THE EXTENT OF SUCH SPENDING  
3 AUTHORITY.

4 (III) THE STATE DEPARTMENT MAY SOLICIT AND ACCEPT GIFTS,  
5 GRANTS, AND DONATIONS FROM PUBLIC OR PRIVATE SOURCES FOR THE  
6 DEVELOPMENT OR IMPLEMENTATION OF REENROLLMENT EITHER OVER THE  
7 TELEPHONE OR THROUGH THE INTERNET PROCESS DESCRIBED IN THIS  
8 PARAGRAPH (e); EXCEPT THAT THE STATE DEPARTMENT MAY NOT ACCEPT  
9 A GIFT, GRANT, OR DONATION THAT IS SUBJECT TO CONDITIONS THAT ARE  
10 INCONSISTENT WITH THIS PARAGRAPH (e) OR ANY OTHER LAW. ANY GIFTS,  
11 GRANTS, OR DONATIONS RECEIVED BY THE STATE DEPARTMENT SHALL BE  
12 TRANSMITTED TO THE STATE TREASURER, WHO SHALL CREDIT THE SAME  
13 TO THE DEPARTMENT OF HEALTH CARE POLICY AND FINANCING CASH FUND  
14 CREATED PURSUANT TO SECTION 25.5-1-109.

15 SECTION 2. 25.5-8-109 (4.5), Colorado Revised Statutes, is  
16 amended BY THE ADDITION OF A NEW PARAGRAPH to read:

17 **25.5-8-109. Eligibility - children - pregnant women - repeal.**  
18 (4.5) (c) SUBJECT TO THE PROVISIONS AND REQUIREMENTS OF SECTION  
19 25.5-4-205 (3) (e), THE DEPARTMENT SHALL ESTABLISH A PROCESS SO  
20 THAT AN ENROLLEE OR THE PARENT OR GUARDIAN OF AN ENROLLEE MAY  
21 APPLY FOR REENROLLMENT EITHER OVER THE TELEPHONE OR THROUGH  
22 THE INTERNET.

23 SECTION 3. **Safety clause.** The general assembly hereby finds,  
24 determines, and declares that this act is necessary for the immediate  
25 preservation of the public peace, health, and safety.
